The quality and standards of early years provision

What is it like to attend this early years setting?

This provision does not meet requirements

Children's safety and well-being is compromised due to significant failings in leadership and management at the setting. The provider's significant lack of oversight has resulted in several beaches to the requirements of the early years foundation stage. Children are placed at significant risk because the provider has failed to ensure that there is a suitable manager in place to lead the setting. In addition, there is no named deputy in place to take charge in the manager's absence. Required documentation, such as evidence of staff suitability checks, qualifications and training are not on site and available for inspection. Children are placed at further risk because the provider has not ensured that at least one member of staff is trained in the role of designated safeguarding lead.

Despite the sheer lack of oversight and support from the provider, the wonderful staff work very hard to maintain the smooth running of setting. They have excellent relationships with parents and have formed strong partnerships with staff at the host school. As result, children are very happy and settled.

Children are extremely kind, thoughtful, and polite. For example, as they walk through the host school, they observe the school rules for walking sensibly so not to disturb others. In addition, they hold open the doors for their friends, staff, and visitors. Staff are very good role models who treat children fairly and with respect. Children enjoy spending time with the staff. For example, outdoors, they eagerly ask staff to join them as they draw and colour in pictures.

What does the early years setting do well and what does it need to do better?

- The provider does not demonstrate a secure understanding of how to meet the early years foundation stage requirements. For example, they have failed to ensure there is an appointed manager to lead and take charge at the setting. In addition, they have not appointed a named deputy to take charge in the absence of the manager. This leaves the setting vulnerable and places children at significant risk of harm.
- The provider does not ensure that all required documentation is on site and available for inspection. Therefore, these could not be checked to ensure staff remain suitable for their roles. These include evidence of staffs' disclosure and barring service checks, that at least one person holds a valid paediatric first-aid qualification and evidence of at least one member of staff trained in the role of designated safeguarding lead. As a result, staff are not equipped to deal with any emergencies that may arise and are unsure of who is responsible to deal with any concerns they may have about a child's welfare. These breaches place children at significant risk of harm.



- Although the provider has told Ofsted about a change of company name, they have not ensured that associated required documentation, such as public liability insurance and the Ofsted registration certificate have been replaced to reflect these changes and that these are displayed correctly, as is required.
- The provider does not have systems in place for the effective coaching and supervision of staff. This poor practice means that staff are not supported in their individual roles. They have no access to their personal records. In addition, they have very limited contact with the provider. This means they are not able to discuss their work and any support they require to maintain their own personal well-being. Staff comment they feel 'very anxious' and are 'left to fend for themselves'. In addition, staff are not provided with any continuous professional development opportunities to enhance their skills.
- Staff encourage children to eat healthily and promote their independence. For example, children help themselves to oranges and breadsticks at snack time and confidently pour their own water.
- Children enjoy their time at the setting. They talk fondly about their friends and the staff. Children particularly enjoy being outdoors. They have many opportunities to practise their physical development skills. Children enjoy various ball games, scale the large equipment, and push each other on the swings.
- Staff work well with staff at the host school to provide activities that complement children's learning. For example, they take part in themed days, such as world-book week. Staff make time to help children with any homework tasks. For example, they discuss different wildlife with the children to consolidate their learning in school that day.

Safeguarding

The arrangements for safeguarding are not effective.

Staffs' suitability, qualifications and training cannot be verified due to required documentation not being available at the inspection. In addition, although staff have a sound understanding of what might make them concerned about a child's welfare, no one at the setting is trained in the role of designated safeguarding lead, as is required. This, alongside the provider's poor oversight of the setting as a whole, leaves children vulnerable and at risk. The setting is safe and secure. Staff work closely with the host school to ensure that children receive consistent levels of care and that the premises remain suitable for use.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

We intend to take steps to suspend registration and will issue a Welfare Requirements Notice requiring the provider to:
