## **Summary of key findings**

#### This provision meets requirements

- Leaders describe how they plan to offer a welcoming, safe, inclusive environment for children. They intend to establish a curriculum that incorporates indoor and outdoor learning. They discuss how they will consider children's development and interests, to support future learning.
- Leaders talk about the activities they will provide for children. This includes building on mathematical knowledge through active games. They describe how they plan to develop children's communication and language, incorporating reading, singing and encouraging engaging conversations with adults and peers.
- Leaders explain how they plan to teach children about the world around them, through joining in with community events and visits to the local area. They describe how they will promote good behaviour and teach children about respect, giving children opportunities to express themselves openly and talk about how they feel.
- Leaders recognise the importance of parent partnerships. They discuss plans to involve parents through family days and regular feedback. They explain how they will share progress with parents to support learning at home. They have ambitious visions for the club and plan to gather parent's input to develop this further.
- Leaders discuss how they will help children acquire healthy habits. This includes teaching children about the benefits of nutritious snacks and implementing healthy practices. They plan to incorporate outdoor learning daily. This will support children's physical health and well-being.
- Leaders understand their duty to keep children safe. They ensure their team undertake regular safeguarding training. This includes understanding broader safeguarding issues, such as the 'Prevent' duty guidance. They explain reporting procedures for concerns about a child or a staff member. They describe how they ensure the premises will be kept safe. This includes completing regular risk assessments.
- Leaders explain how they support continuing professional development with staff. They use local authority and external training to build on existing knowledge. They describe the open culture they want to provide for the team. This includes regular well-being checks and supervisions.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Fray Bambino After Care registered in 2019. It operates from a church premises within the London Borough of Lambeth. The service operates each weekday from 7.30am to 9am before school and from 3.30pm to 6pm after school during school term times. They employ five staff members. Of these, one holds a playworker qualification and the others hold relevant childcare qualifications at levels 2 and 3.

- The manager showed the inspector key documentation, including information to demonstrate the suitability of staff.
- The inspector spoke with the nominated individual about the leadership and management of the setting.
