## Summary of key findings

### This provision meets requirements

- The childminder understands how to manage children's behaviour. She recognises the need to teach children to be independent and to help them to develop their confidence and self-esteem. The childminder explains how she helps children to develop positive relationships and be kind and respectful.
- The childminder recognises the importance of close partnerships with parents and other professionals. She understands her responsibilities in assessing children's learning and development and how to share this information with the necessary people.
- The childminder understands how to help children lead a healthy lifestyle. She plans to provide healthy snacks and meals. She describes how children will spend time outdoors going to the park and on trips. She recognises the importance of children being physically active.
- The childminder has a clear understanding of how to safeguard children. This includes the procedure to follow if she has concerns about children or parents displaying extreme views or behaviour. She knows the possible signs and symptoms of abuse and how to refer any concerns to the relevant authorities.
- The childminder explains how she uses a range of teaching skills to meet children's individual learning styles and to support her curriculum. She understands how to identify and swiftly respond to any gaps in their learning.
- The childminder knows the importance of professional development to improve continuously the quality of her practice. She has attended a range of training courses to develop her knowledge and skills.
- The childminder understands how to build close bonds with children and how to keep children safe. She has up-to-date knowledge of how to meet the needs of children in the event of an accident or incident. She holds a current paediatric first-aid certificate.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### Inspection activities

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the childminder.
- The inspector looked at the policies and documents the childminder will use when caring for children.
- The inspector asked the childminder questions throughout the inspection to establish her understanding of how to safeguard children.
- The inspector discussed with the childminder how she supports children's learning and development.
- The childminder and the inspector completed a learning walk together.
- The inspector viewed the resources and looked at the areas of the premises that are used for childminding.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
