Summary of key findings

This provision meets requirements

- The childminder has a secure understanding of safeguarding. She knows her role and responsibility to ensure that children are kept safe and protected. The childminder has kept her safeguarding knowledge up to date. She now maintains up to date first-aid training.
- The childminder's home is a welcoming and secure environment for children. She knows how to risk assess children's activities and her provision to help to keep children safe. Children will also learn how to manage their own safety. For example, learning about road safety and waiting for the 'Green Man'.
- The childminder confidently describes how she will monitor children's progress and identify any gaps in their learning. She will identify children's next steps for learning to support their development.
- The childminder explains how she will plan a range of indoor and outdoor activities to support children's learning. She recognises the importance of ensuing children have a range of experiences to develop their skills. For example, regular trips to the library for rhyme-time sessions to help support children's communication and language skills.
- The childminder understands how to nurture children's confidence and emotional well-being. She identifies how to settle children into her setting. The childminder knows how to support children's positive relationships with her and their peers. Children will have regular opportunities to sing familiar songs and express themselves through action rhymes. For example, they will sing the 'Wheels on the Bus' and 'Sleeping Bunnies'.
- The childminder understands how to support inclusion and celebrate diversity to help children learn positively about others. She has good awareness of how to support children who speak English as an additional language.
- The childminder discussed her understanding of the importance of working with parents, carers and other professionals. She describes how she will share information with parents on a regular basis.
- The childminder understands how to support children's behaviour positively. She understands that younger children may need extra support to manage their feelings. Children will be supported to work together, learn to share and take turns.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector and childminder had a discussion on how she evaluates her provision and her plans for improvement.
