Summary of key findings

This provision meets requirements

- The childminder has a good knowledge of how to keep children safe. She understands the different types of abuse and the signs that may indicate a child is at risk. The childminder knows how to record and report concerns to the relevant agencies. She completes regular risk assessments of all areas of her home to help keep children safe.
- The childminder understands how to provide a curriculum for children when they attend. She describes how she will plan for children's individual needs and interests, and knows how to monitor children's development. The childminder has a good selection of toys and resources available for children to use.
- The childminder understands the importance of working in partnership with parents. She explains how she intends on sharing information with parents about their children's learning and development. The childminder describes how this will enable parents to support their child at home.
- The childminder has high expectations for children's behaviour. She discusses how she will use suitable strategies to manage their behaviour. The childminder talks about how she will reinforce children's positive behaviour to develop their self-esteem.
- The childminder describes how she intends on promoting children's understanding of healthy lifestyles. She explains how she will provide children with healthy and nutritious meals, and daily experiences for physical play. The childminder understands the importance of helping children to develop good hygiene routines, including oral health.
- The childminder knows how to reflect on her practice and identify areas for development. She intends on seeking the views of parents and children to include them in the process.
- The childminder understands how to promote diversity and inclusion within her home and the local community, so that all children have a sense of belonging. She knows her responsibility to teach children to respect others.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the childminder about her knowledge and understanding of keeping children safe.
- The childminder explained how she supports and monitors children's learning and development.
