Inspected under the social care common inspection framework

Information about this children's home

This children's home is run by a private organisation in partnership with the local authority. The home provides placements for children with disabilities and young people with a diagnosis of autism spectrum disorder. The home provides care for up to six children and young people permanently, and up to three children and young people under short-break arrangements.

The home has been without a registered manager since July 2021.

This monitoring visit

This visit was carried out to review the provider's compliance with an imposed condition and to assess the progress made in meeting ten requirements and one compliance notice. These were issued following a full inspection that was carried out on 16 and 17 May 2022 and resulted in the home being judged inadequate.

Leaders have completed a comprehensive action plan. A review of the action plan indicates that significant steps have been taken to address safeguarding concerns.

Staff talk confidently about the changes that have been made since the last inspection, confirming a renewed focus on safeguarding in team meetings, supervisions and in daily handovers. Staff are now clearer about their responsibilities and the requirement to raise any concerns.

External safeguarding professionals speak confidently about the response the provider has taken to address previous concerns.

There is a renewed focus to ensure that there is good management oversight. Monthly audits, combined with quarterly reviews by the wider organisation, are ensuring that children's care is being carefully monitored and reviewed.

Leaders have identified specialist training to ensure that staff in supervisory roles have adequate skills to identify and report concerns.

The manager is in the process of applying to be registered with Ofsted.

The compliance notice was deemed met. Although a lot of progress has been made in addressing all ten requirements, these have not yet been embedded. As a result, these requirements have been reissued.
