### What is it like to attend this early years setting?

#### This provision meets requirements

Staff are passionate about creating a fun and friendly environment for children to enjoy. Children independently choose what they would like to do from a wide range of activities. Staff use children's interests to plan which activities to provide, although children are aware they can ask staff for any resources they may like. There are opportunities for quieter activities, such as reading in the comfy corner. Other children prefer to run around in the playground. They enjoy kicking footballs or playing tennis with staff and their peers. Staff talk to children about the hot weather. They support them in making safe decisions about where they play and how to keep cool.

Staff safely collect younger children from the school. Children talk excitedly about what might be available for them today. Children and staff have very positive relationships. Children are keen to talk to staff as they arrive. Younger children tell staff about the teachers they are going to have next year. Older children discuss moving on to high school. Children talk openly to staff about how they feel regarding moving school. They support children as they talk through their thoughts and feelings. They discuss the good points together to help children become excited about their next adventure in their learning journey.

# What does the early years setting do well and what does it need to do better?

- Children have a real sense of belonging within the club. Golden rules, created by the children, creates ownership of how they behave. Due to this all children behave well. Children are happy to support each other and be helpful. For example, younger children ask their older peers to help them make flowers with the pipe cleaners. Older children are happy to support and spend time teaching them how to do this on their own.
- Younger children each have a key person within the club. They work closely with the school and parents, ensuring that information sharing is effective. Staff know their key children well, supporting their well-being while at the club.
- Staff support children to develop knowledge of creating healthy lifestyles. When children arrive, they have the option of a healthy snack. Children talk about how they enjoy the variety of snacks available. They state, 'There is always something I like.' Children independently make their snack. Throughout the session children have access to an outside area. They run, climb and explore, developing their physical skills.
- Staff plan the outside area to encourage all children to access fresh air. Younger children sit and share books with older children. They take turns reading a page of the book each, practising their reading skills. Other children lie on a picnic blanket looking at the trees in the shaded area. They talk about the songs for an



upcoming assembly they are taking part in. Children relish the freedom they have to explore the outside space. This freedom helps children to develop confidence in their choices.

- The manager and her team have a good relationship with all staff at the school. They work together to support children when issues arise. For example, staff are involved in meetings regarding children's behaviour at school. This ensures a consistent approach is taken. Children are complimentary of the club and talk of their enjoyment in coming.
- Parents talk fondly of the manager and her team. Parents explain how happy their children always are when they collect them. They compliment the level of communication they receive, and they do not feel they miss any communication coming from the school. Children enjoy attending, which is very important to parents. The wide range of art and craft activities is a highlight for children and their parents.
- The manager works well with her team to ensure their ongoing development. The team have access to a wide range of training to support the development of their knowledge. The manager talks with her team daily to discuss the activities which are going to be available. Staff feel well supported and part of a team.

#### Safeguarding

The arrangements for safeguarding are effective.

Staff are knowledgeable of the signs and symptoms of abuse. Staff know the reporting processes and are confident in their explanations. Wider safeguarding issues, such as the 'Prevent' duty guidance and county lines, are known by staff. Staff know the process for reporting a concern about a member of staff. The manager ensures the ongoing suitability of the staff team. Staff talk to children about internet safety, sharing information with parents when required. Bullying and cyber-bullying become topics of conversation as issues arise. Children are comfortable to share issues or concerns with staff. This ensures children are kept safe.

- The inspector talked to staff at appropriate times during the inspection and took account of their views.
- The inspector observed the quality of activities provided, indoors and outdoors, and assessed how the play environment is organised.
- Parents shared their views of the club with the inspector.
- The manager showed the inspector documentation to demonstrate the suitability of staff.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
