Summary of key findings

This provision meets requirements

- The childminder has a good understanding of how to safeguard children and protect them from harm. She is familiar with the signs of abuse and neglect. The childminder knows the procedures to follow should she have a concern about a child's welfare, or if an allegation is made against her.
- The childminder intends to provide an ambitious curriculum, to build on children's knowledge and skills. She explains how she will find out about children's individual needs and interests, and use these to help her plan the educational programmes.
- The childminder understands the need to support children's independence and to help them to develop confidence and self-esteem. She outlines how she will arrange the learning environment, so that children can make choices about their play.
- The childminder recognises the importance of close partnerships with parents, to support children's care and learning. She understands that she must assess children's development and share this information with parents, to help them support children's progress at home.
- The childminder explains how she will help to enrich children's lives, by providing them with a variety of experiences. For example, she plans to take them on daily outings, such as to a library, farm, shops and parks. She explains how this will help them to learn about their local environment and community.
- The childminder knows how to set clear boundaries and expectations, to support children's behaviour. She places importance on teaching children how to express their feelings and regulate their actions. The childminder explains how she will help children to develop positive relationships and teach them to be respectful towards others.
- The childminder understands how to promote healthy lifestyles for children. She describes how she will provide healthy meals and snacks. The childminder recognises the importance of being physically active. She explains how she will take children on daily walks and visits to parks, so that they can exercise and develop their large-muscle movements.
- The childminder explains how she will evaluate her provision, to identify ways to improve the outcomes for children. She understands the importance of keeping her professional development up to date, to ensure that she meets the registration requirements.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The childminder spoke to the inspector about her curriculum plans and intentions for children's learning.
- The childminder explained how she will meet the safeguarding and welfare requirements, when caring for children.
- The inspector looked at a sample of the childminder's documentation, this includes her public liability insurance and paediatric first-aid certificate.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
