#### Information about this children's home

The home is run by a private provider. It is currently registered to care for up to nine children with learning disabilities.

There has been no registered manager in post since May 2021. The current manager has applied to register with Ofsted.

# This monitoring visit

This home was judged inadequate at the full inspection on 4 and 5 May 2022.

A monitoring visit took place on 16 June 2022 to monitor the notice to restrict accommodation of any further children until 1 August 2022. The visit also assessed the progress made by the provider to meet the steps set out in four compliance notices issued under section 22a of the Care Standards Act 2000 after the full inspection. These related to regulation 8 (the education standard), regulation 12 (the protection of children standard), regulation 13 (the leadership and management standard) and regulation 35 (behaviour management policies and records). The provider demonstrated sufficient progress to meet the notice served under regulation 35 only.

This second monitoring visit took place to assess the progress made to meet the steps set out in three new compliance notices served under regulations 8, 12 and 13. The restriction of accommodation was also monitored.

One child has moved on from the home. One child remains living there. The provider continues to comply with the restriction of accommodation notice.

A new format for children's care plans has been introduced. These clearly identify children's educational needs, which are informed by local authority plans, including personal education plans and education, health and care plans. The new plans include how the staff should support children to achieve individualised targets. Records track how children are helped to make progress.

The provider has introduced an ongoing and comprehensive training programme for the staff team. The staff have received training to meet the specific needs of children. This equips the team with the skills to deliver safe care.

Significant progress has been made to address repairs and redecoration in the home, to ensure it is a safe and more homely environment for children to live in. One area of the home which required the most attention is close to completion.

Clear and individualised care planning is now evidenced that tracks children's progress. Plans are regularly monitored and reviewed by leaders and managers in the home. Files include additional monitoring tools to demonstrate children's development and achievements over time.

In addition to the ongoing training for staff, a team development day was delivered by an external provider. A member of staff indicated that this had been well received and supported a committed team ethos.

New management monitoring tools are becoming embedded to improve oversight and practice in the home. Further improvements to audit tools have been identified and introduced. The manager reviews incident records to identify further practice development needs.

Other requirements and recommendations made at the last full inspection were not considered at this visit and are carried forward to the next inspection.

The appointed manager has submitted his application to register with Ofsted. The provider has applied to reduce the number of children living at the home to six.

A case review was held on 28 July 2022. The decision was made that the provider has made sufficient progress to meet the steps in the three compliance notices. The restriction of accommodation has been lifted.

# What does the children's home need to do to improve? Statutory requirements

Specifically, that the staff follow children's individualised plans to ensure that children's care promotes their welfare and accords with their relevant plans.	
The registered person must maintain records ("case records") for each child which—	28 August 2022
include the information and documents listed in Schedule 3 in relation to each child. (Regulation 36 (1)(a))	
This relates specifically to ensuring that the registered provider obtains all relevant plans and reports relating to children to ensure that the staff deliver care that meets placing authorities' expectations.	
The registered person must notify HMCI and each other relevant person without delay if—	28 August 2022
there is any other incident relating to a child which the registered person considers to be serious.	
A notification made under this regulation—	
must include details of—	
the matter;	
the other persons, bodies or organisations (if any) who or which have been notified; and	
any actions taken by the registered person as a result of the matter;	
must be made or confirmed in writing. (Regulation 40 (4)(e) (5)(a)(i)(ii)(iii)(b))	



#### Recommendations

- The registered person should ensure that the independent person appointed completes a rigorous assessment that identifies areas for practice improvement and regularly considers the views of stakeholders. ('Guide to the Children's Homes Regulations, including the quality standards', page 65, paragraph 15.5)
- The registered person should ensure that consideration is given to the frequency of supervision. Staff members' performance should be appraised formally on an annual basis to drive improvements in practice. ('Guide to the Children's Homes Regulations, including the quality standards', page 61, paragraphs 13.1 and 13.5)
- The registered person should ensure that electronic records, for example in relation to recruitment, are easily accessible to individuals who legitimately need to view them. ('Guide to the Children's Homes Regulations, including the quality standards', page 61, paragraph 14.2)
