What is it like to attend this early years setting?

The provision is outstanding

Children flourish in this nursery. All children, including those with additional needs, are making exceptional progress in their learning. Children's behaviour is exemplary and the most able children help other children to understand the boundaries and expectations. For example, children remind each other to stand back to allow everyone to participate in the bug hunt.

Children show high levels of confidence and the older ones in particular lead their own learning. Management and staff have high expectations of what they want the children to achieve. Consequently, children leave the nursery well prepared for their next stage in their learning or the move on to school. Children build very secure relationships with staff and children. They show great excitement when they go outside and enjoy a multi-sport session. This enables them to gain confidence and new skills.

During the COVID-19 pandemic, staff worked closely with parents. Staff maintain highly effective relationships and regularly check with parents to see how they feel their child is progressing. For example, staff have created a sensory room and speech and language groups to support children in their personal, social and emotional development and their communication and language skills. Parents comment that staff know their children exceptionally well and that nursery staff go over and above for their children.

What does the early years setting do well and what does it need to do better?

- The management team is extremely passionate about providing high-quality care and education. It strives to ensure it is inclusive to every child, to make sure they make the maximum progress from their starting points. The management team works exceptionally well with other agencies to make sure that support is targeted and it provides high-quality support to the families as well.
- The curriculum is targeted to every child. Staff use highly effective teaching methods to make sure that children are keen to participate in a wide range of activities, predominantly child-led activities. Staff are enthusiastic and know the children exceptionally well. This enables them to plan stimulating activities to complement the children's own interests and ideas. For example, children are keen to look for bugs and they predict how many they will find, completing a tally sheet to record the actual number. This promotes all areas of their learning.
- Parents are highly valued, respected and encouraged to share what they know about their child's development and learning. Regular parent meetings and an online system allow parents to contribute. Staff use these opportunities to share ideas of how they can support their children's learning further at home. Parents



talk about activities that particularly spark their children's interest, such as observing duck eggs hatching into ducklings. Parents also enjoy the extra activities, such as fun days, and feel their children benefit a lot from these opportunities.

- The special educational needs coordinator (SENCo) is exceptionally knowledgeable about the children in the nursery. She role models and provides additional training and, along with the manager, has regular meetings with the staff to share ideas and talk through any issues. Parents are fully involved in this process and children's uniqueness is celebrated.
- Staff provide a stimulating environment where they consider effectively how to make sure children can access the resources independently. Children show high levels of confidence as they select the equipment. Staff use a lot of natural resources to enhance children's learning.
- Children benefit from healthy and nutritious snacks and meals and their dietary needs are met effectively. Children learn about where food comes from as they grow fruit and vegetables. Staff place a high emphasis on healthy lifestyles. Children learn about oral health and how physical exercise supports their mental health and development. Children thoroughly enjoy playing different sports and show a great sense of perseverance as they try to learn ball skills. Children spend considerable time trying to get the ball in the net and beam with pride when they achieve this.
- The manager and the SENCo use additional funding exceptionally well to support children's individual progress. For example, providing one-to-one support with clear targets to help each child make the best possible progress from their starting point.

Safeguarding

The arrangements for safeguarding are effective.

Staff are exceptionally knowledgeable and the committee provides a safeguarding officer to make sure policies and procedures are followed correctly. Staff have highly effective relationships with other agencies to ensure children's health, safety and well-being are exceptionally well promoted. Staff are constantly risk assessing the environment and involve the older children to enable them to identify and minimise risks. Children use a wide range of equipment safely. Although recruiting qualified staff has been difficult, the nursery has highly effective induction procedures to ensure staff are fit for their role and responsibility.

Information about this early years setting

The Orchard Nursery first registered in 2004 and re-registered in 2014. It operates from within the grounds of Christ the King Primary School, in Kinson, Dorset. The nursery operates for 51 weeks of the year. It is open every weekday, from 8am to 6pm. The nursery receives funding to provide free early years education for children aged two, three and four years. A team of 18 staff work with the children. Most of the staff hold early years qualifications, including two with qualifications at level 4 and one with a qualification at level 5.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with leaders and has taken that into account in their evaluation of the setting.
- The manager and the inspector observed an activity together and completed a learning walk where they reflected on the quality of teaching and learning and the curriculum offered.
- The inspector spoke with parents and read letters provided specifically for the inspection to gain their views.
- The inspector spoke with staff and children at appropriate times throughout the inspection.
- The inspector held a leadership and management meeting with senior staff to establish how they monitor and evaluate the provision.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
