Summary of key findings

This provision meets requirements

- The childminder is kind, caring and welcoming. She is a knowledgeable practitioner and has a very good understanding of how children learn and develop. She clearly demonstrates how she will provide a broad curriculum for all children, that considers their ages and stages of development, and prepares them well for the next stage of learning.
- The childminder talks about how she will support children who speak English as an additional language. She understands the importance of parents helping children master their home language. She would support children learning English by singing songs, reading books and attending story time sessions, so that children can hear native English speakers.
- The childminder talks about how she would help children learn about their wider world and local community. She explains how she would plan regular trips to local places of interest, playgroups, shops and museums to support their learning.
- The childminder is passionate about teaching children to understand and respect differences between themselves and others. She would do this by teaching children about different cultures, using a range of resources that reflect diversity and looking at communities in the local area.
- The childminder has a secure understanding of her role and responsibilities in relation to keeping children safe. She knows the signs that indicate a child is at risk of harm and what to do if she has concerns. The childminder ensures her knowledge of safeguarding is up to date through training.
- The childminder describes how she will build partnerships with parents and other settings children attend. For instance, she would observe children with their parents and gather vital information about them before they start at her setting, to ensure a smooth transition.
- The childminder explains how she would help children learn about healthy eating. For example, she would help them grow fruit and vegetables and take them out to shop for healthy food options.
- The childminder would reflect on the quality of her practice to identify areas for further development. For instance, she has a questionnaire for parents to complete every three months about the setting and children's learning. This should help to improve outcomes for all children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2012. She lives in Tooting, in the London Borough of Wandsworth. The childminder provides care from 8am to 6pm on Monday to Friday and operates her service for most of the year. The childminder holds a relevant early years qualification at level 3.

Inspection activities

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken this into account in their evaluation of the setting.
- The inspector viewed the premises, toys and resources with the childminder. She talked with the childminder about how she would use these to promote children's learning.
- The inspector viewed relevant documentation, which included the childminder's paediatric first-aid qualification, insurance and Disclosure and Barring Service checks for adults living in the home.
- The inspector spoke with the childminder to find out how she would use experiences and activities to support children's learning and development.
- The inspector talked with the childminder about her safeguarding knowledge and how she would keep children safe.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
