Summary of key findings

This provision meets requirements

- The childminder completes child protection training to keep her safeguarding knowledge up to date. She has written policies and procedures to follow and share with parents. The childminder has a clear understanding of how to identify the signs and indicators of abuse. She knows how to respond to concerns about a child's welfare, or in the event an allegation is made.
- The premises are clean, safe and suitable for childcare purposes. The childminder has procedures in place to complete effective risk assessments and understands how to minimise hazards to children.
- The childminder has high expectations of children's behaviour. She plans to consistently reinforce her expectations and set clear boundaries. The childminder discusses how she will teach children to manage and resolve conflicts, and understand the impact that their actions have on others.
- The childminder plans to provide an ambitious curriculum that covers the learning and development requirements of the early years foundation stage. Through discussion, the childminder explains how she will use her observations and assessments to monitor children's progress. She plans to provide educational programmes and activities based on children's interests and stages of development.
- The childminder places an importance on working in partnership with parents and other professionals. She explains how she will gather and share information with parents to support children's individual care and learning needs. The childminder plans to link parents to outside agencies, where concerns arise about a child's development. She plans to work collaboratively with them to ensure that children receive the individual support that they need.
- The childminder has processes in place to reflect on and evaluate her practice. Through discussion, she explains how she will seek feedback from parents and external professionals to help to identify areas to improve her service. The childminder values the importance of accessing training for her continued professional development and to help to maintain requirements.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
