Information about this secure children's home

This secure children's home is managed by a local authority. It is approved by the Secretary of State to restrict children's liberty. The home can accommodate up to 24 children aged between 10 and 18 years. There were nine children living at the home at the time of this inspection.

All places available at the home are commissioned on a contractual basis by the Youth Custody Service (YCS). The YCS may, under certain circumstances, permit local authority children's services to spot-purchase a vacant bed at the home, to enable a local authority to place a child on welfare grounds under section 25 of the Children Act 1989. Admission of any young person under section 25 of the Children Act 1989 who are under 13 years of age requires the approval of the Secretary of State.

The commissioning of health services at this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided on site in dedicated facilities.

There has been no registered manager since 17 May 2022.

This monitoring visit

This monitoring visit was carried out in line with the memorandum of understanding between Ofsted and the Department for Education (DfE).

Inspectors visited the home with specialist architects commissioned by the DfE. This visit forms part of the information that Ofsted provide to the DfE so that the Secretary of State can make a decision about the continuing suitability of the home to restrict children's liberty.

Improvements have been made to the physical environment to ensure that it is safe and secure. Some maintenance work remains ongoing, including the refurbishment of the bathrooms in some children's bedrooms. There are plans in place to carry out this work in the near future.

The requirements and recommendations made at the last inspection will be reviewed at the next inspection.

Statutory requirements

Specifically, ensure that all staff follow the home's policy in relation to wearing smartwatches when accessing areas where children are present.	
The registered provider must appoint a person to manage the children's home if—	30 September 2022
there is no registered manager in respect of the home; and

is an organisation or a partnership;	
does not satisfy regulation 28; or	
is not, or does not intend to be, in day-to-day charge of the home. (Regulation 27 (1)(a)(b)(i)(ii)(iii))	
The registered person must ensure that all employees—	30 September 2022
receive practice-related supervision by a person with appropriate experience. (Regulation 33 (4)(b))	
Specifically, ensure that staff supervision records fully reflect conversations about learning from significant incidents.	
The registered person must ensure that an independent person visits the children's home at least once each month.	30 September 2022
When the independent person is carrying out a visit, the registered person must help the independent person—	
if they consent, to interview in private such of the children, their parents, relatives and persons working at the home as the independent person requires; and	
to inspect the premises of the home and such of the home's records (except for a child's case records, unless the child and the child's placing authority consent) as the independent person requires.	
A visit by the independent person to the home may be unannounced.	
The independent person must produce a report about a visit ("the independent person's report") which sets out, in particular, the independent person's opinion as to whether—	
children are effectively safeguarded; and	
the conduct of the home promotes children's well-being.	
The independent person's report may recommend actions that the registered person may take in relation to the home and timescales within which the registered person must consider whether or not to take those actions.	



The independent person must provide a copy of the independent person's report to—	
HMCI;	
upon request, the local authority for the area in which the home is located;	
the placing authorities of children;	
the registered provider and, if applicable, the registered manager; and	
the responsible individual (if one is nominated).

Recommendations

- The registered person should ensure that the ethos of the home supports each child to learn. In particular, managers should embed and secure the new monitoring and tracking tools into the work of the school so that the increased shared understanding this provides informs the planning of the curriculum for each child, and, formalise the careers programme so that it can be tailored to the needs of individual children based on their aspirations and plans. ('Guide to the Children's Homes Regulations, including the quality standards', page 29, paragraph 5.18)
- The registered person should seek, as far as possible, that the home maintains a domestic rather than 'institutional' impression. ('Guide to the Children's Homes Regulations, including the quality standards', page 15, paragraph 3.9)
