Summary of key findings

This provision meets requirements

- The provision is suitable and safe to provide care and education to children. The provision offers large rooms equipped appropriately to cover all aspects of children's learning. In addition, there is a large outdoor space, which is fenced and secure.
- Leaders show good knowledge and understanding of the statutory requirements. They discuss with confidence how they consider children's views and interests when planning learning opportunities. Furthermore, planned activities are enhanced regularly to ensure they have a positive impact on children's learning and development.
- Leaders have effective systems in place to build and maintain strong relationships with the parents and carers and other agencies, such as the local authority or children's community centre. This includes obtaining regular feedback and reflecting on it accordingly.
- Leaders demonstrate inclusive vision and practice. They have robust knowledge and understanding on how to support more vulnerable children, including those who speak English as an additional language.
- Leaders value their staff and continuously focus on their well-being and professional growth and development. They identify and analyse training requirements and effectively implement them into practice.
- Leaders have an ambitious vision for their setting; to have a positive impact on all children in their care and on their local community. They display the ability to reflect and continuously seek ways to improve and further develop their provision.
- Leaders understand it is very important to keep children safe. They have sound knowledge and understanding of safeguarding, including wider aspects of safeguarding, such as the 'Prevent' duty and county lines. Leaders are clear about where to refer any concerns they may have about a child in their care. Furthermore, they have robust procedures in place to ensure all staff are trained regularly to follow the same vision.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held a meeting with the leaders. She looked at relevant documentation and reviewed evidence of the suitability of the leaders and staff members.
- The leaders discussed how they organise the activities taking into account children's interests.
- The inspector viewed the provision and discussed the safety and suitability of the premises.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
