Summary of key findings

This provision does not meet requirements

- The childminder demonstrates an understanding of the importance of play for young children. She talks confidently about providing a balance of adult-led and child-initiated play. She provides a good range of resources to promote children's interaction and engagement with others. However, the childminder has a limited understanding of some of the areas of learning and how young children learn.
- The childminder understands her responsibility to keep children safe from harm. She demonstrates some knowledge of the procedures she must follow to promote children's welfare and ongoing emotional well-being. The childminder can identify the signs and symptoms of child abuse. However, she does not have a confident knowledge of the procedures to follow if an allegation was made against her or a household member. Additionally, the childminder does not have a secure knowledge of how to identify children who may be at risk of radicalisation or extremism.
- The childminder has a clear knowledge of how to promote children's hygiene and physical well-being. She talks about how she will provide healthy foods for children and will share information with parents about healthy meals. She understands the importance of hygiene routines. The childminder explains how she will be encouraging physical exercise and daily fresh air to help develop children's enthusiasm for a healthy lifestyle.
- The childminder demonstrates how she will help children to develop their selfesteem. She talks about the importance of acting as a positive role model for children to support their understanding of appropriate behaviour towards others. She talks about including independence and self-help skills into their daily routines to help support their readiness for school.
- The childminder has the required documentation in place to help her manage day-to-day organisation, such as recording minor accidents and maintaining a record of children's attendance.
- The childminder has a positive attitude towards evaluating her service. She uses local support networks and local authority advisors to gain further knowledge towards changes in regulation.
- The childminder demonstrates a keen awareness of working closely with parents to promote a consistent approach to children's learning and care. She talks about talking on a daily basis with parents to share information about children's achievements and their next steps in their learning.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
