Summary of key findings

This provision does not meet requirements

- The childminder failed to complete a Disclosure and Barring Service check in a timely manner for a member of the household. She also failed to provide Ofsted with the information about the check when requested to do so.
- The childminder does not have sufficient knowledge and understanding of the requirement to notify Ofsted of changes to the household.
- The childminder has all the required child protection policies and procedures in place and knows about the possible signs of abuse and neglect. However, she does not understand that she has a duty to report her concerns, without delay, to the agencies with local statutory responsibilities.
- The childminder has poor knowledge of recording the required information and maintaining records for a reasonable period of time after children have left. She has destroyed the record of children's daily attendance for the children she has cared for. She does not understand the importance of recording information about children's emergency contacts and any special dietary requirements.
- The childminder does not understand the assessment requirements. She does not have a system to monitor children's progress. In addition, she does not understand the need to complete a progress check for children aged between two and three years and share this with parents.
- The childminder does not have a secure knowledge of how to use the seven areas of learning and development to shape the educational programmes for children. The range of available resources is poor and there are weak systems in place to teach children about diversity.
- The childminder is ineffective in evaluating her provision and identifying areas for improvement. She lacks knowledge of the 'Statutory framework for the early years foundation stage' and is unable to demonstrate her capacity to improve.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:



provide Ofsted with information as required to ensure that the suitability of adults who live in the household and have regular contact with children can be assessed	16/09/2022
improve knowledge and understanding of the requirement to notify Ofsted of the changes to the household	16/09/2022

- The inspector looked at a sample of the childminder's documentation. This includes information about the suitability of household members and her policies and procedures.
- The inspector held discussions with the childminder.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
