Summary of key findings

This provision meets requirements

- The childminder has met the actions raised at her previous inspection to improve outcomes for children. She has reflected on her practices and updated her knowledge and skills through additional training.
- The childminder has a secure knowledge of safeguarding issues. She understands her role and responsibility to ensure that children are kept safe and protected. The childminder and her assistant maintain up-to-date first-aid training.
- The childminder provides a safe and secure environment for children. She uses risk assessment effectively to minimise potential hazards. Children also learn how to manage their own safety. For example, they learn about road safety and listening out for traffic.
- The childminder confidently describes how she will monitor children's progress and identify any gaps in their learning. She will identify children's next steps for learning to support children's development.
- The childminder explains how she will plan a range of indoor and outdoor activities to provide children with a range of learning experiences. For example, children learn about the life cycles of caterpillars and are introduced to new words, such as 'chrysalis'. During outings to the park, children learn about seasonal changes and explore the texture of leaves.
- The childminder understands the importance of developing children's communication and language. Children are supported to develop a love for books. The childminder explains that children enjoy listening to stories such as 'The Gruffalo'. She explains how she encourages them to use language to anticipate what will happen next.
- The childminder understands how to support inclusion and celebrate diversity to help children learn positively about others. She has a good awareness of how to support children who are learning English as an additional language.
- The childminder understands the importance of working with parents, carers and other professionals. She describes how she will share information with parents on a regular basis. She has considered how she can further support good communication through the use of daily contact journals.
- The childminder describes how she will manage children's behaviour positively. Children will be supported to manage their feelings through discussions. They will be encouraged to share and take turns.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
