# **Summary of key findings**

#### This provision does not meet requirements

- The provider has failed to ensure that suitable public liability insurance is in place for the out-of-school club. There are no children on roll at present, therefore the impact is not significant. However, this is a breach of the early years foundation stage legal requirements.
- The provider can demonstrate a clear understanding of his role and responsibility to keep children safe from harm. He has a secure knowledge of the signs and symptoms of abuse and what constitutes a concern. The procedures for referring concerns about children or staff are in place.
- The provider has high expectations for children's behaviour. He understands the importance of implementing clear rules and boundaries and sharing these with children. The provider is clear about how he will support children to learn about kind, considerate and friendly behaviour.
- The provider understands the importance of supporting children's good health and promoting their well-being. The club offers a broad and balanced snack menu, ensuring children always have access to fresh fruits and vegetables. Outdoor play is an integral part of the club itinerary. A variety of equipment, such as bicycles and scooters, are available to support children's physical development.
- The provider and the staff team reflect on the programme of activities that they provide. They value children's views and opinions and incorporate these into weekly planning. Staff work closely with the host school to provide experiences that complement what children are learning at school.
- Staff have access to a range of professional development opportunities and training to support their skills and knowledge. They complete mandatory training, such as paediatric aid, along with safeguarding and food-safety training. Company staff meetings offer the opportunity to share good practice and help to foster a culture of continuous improvement.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- The inspector spoke with the provider about the leadership and management of the setting.
- The provider showed the inspector documentation to demonstrate the suitability of staff.
