Summary of key findings

This provision does not meet requirements

- The nominated individual and the acting manager have not ensured the premises are safe and secure for children. In several areas of the setting there are significant issues with the premises. Outdoors there are fence panels missing. An external door with a secure entry system is broken. Inside, a room which leads to different premises is left unlocked. This means children could leave the premises unsupervised. Furthermore, unauthorised adults could enter the setting and gain access to children. This presents a significant risk to children's safety.
- The nominated individual and the acting manager have not completed adequate risk assessments. Some areas of the setting contain inappropriate items which could be harmful to children. In the toilets, cleaning products and decorating materials are left where children can access them. The provider has not ensured these items are stored safely.
- The nominated individual does not have public liability insurance in place for the setting.
- The nominated individual has not ensured that a member of staff has a paediatric first-aid qualification.
- The first-aid box is unsuitable. The nominated individual has not ensured it is checked regularly. Some first-aid equipment, such as eye wash, has passed its expiry date. This means the items are unsuitable to use if required. Paediatric first-aid treatment could not be administered to children effectively.
- Despite the above weaknesses, the acting manager has a secure knowledge of the signs and symptoms of abuse. She knows who to report concerns to in line with local safeguarding partnership guidance. The acting manager is confident on the procedure to follow should an allegation be made against a staff member.
- The acting manager explains, through discussion, how she plans to meet the learning and development requirements. She explains how she will find out all about children before they start, and plan activities to suit the next stages of their learning.
- The acting manager explains how she will encourage children to behave in a positive way. She describes how she will support children to take turns and share with other children. The acting manager discusses how she will praise children when they are kind to other children.
- The acting manager demonstrates that she is aware of how to develop an effective partnership with parents. She will hold daily conversations with parents to ensure there is constant communication. The acting manager will work in partnership with other agencies that support children.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:
