Summary of key findings

This provision does not meet requirements

- The childminder has not kept her first-aid certificate up to date, which has elapsed for a lengthy period of time. This is a breach of requirements. However, she has made attempts to refresh her knowledge and arrangements to renew her first-aid certificate. She can currently demonstrate sufficient knowledge of actions she will take in the event of any medical emergency occurring.
- The childminder understands the need to regularly risk assess her home to ensure it is safe, secure and free of any hazards or dangers.
- The childminder demonstrates a secure understanding of promoting positive behaviour. She demonstrates how she will support children with managing their feelings, promoting good manners and encouraging them to respect others.
- The childminder describes how she will observe children's development. She will provide resources and activities to support children's future learning. The childminder identified how she will work with parents and other professionals if gaps in children's learning are identified.
- The childminder explains how she will support children to develop a healthy lifestyle. She will provide children with healthy foods and provide opportunities for children to be active in the outdoors.
- The childminder understands her role and responsibility to safeguard children. She has knowledge of the signs and symptoms of abuse and explains the procedures she would follow if she had a concern about children's welfare.
- The childminder understands the importance of having positive relationships with parents. She describes how she would gather information about children's development and care needs. She explained how she will share children's learning and provide ideas to parents to extend learning at home.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
