## Summary of key findings

#### This provision meets requirements

- Leaders and managers are ambitious. They aim to provide a home-from-home environment in which children feel happy and safe and develop friendly relationships with the staff and their peers. Leaders understand the importance of effective self-evaluation, to plan for improvements and to meet individual children's needs.
- Staff understand the importance of planning a range of activities to support children of all ages and abilities to follow their interests in play. This includes themes such as 'All About Me' to create opportunities for children to talk about what makes them unique. Leaders consider ways to further enhance opportunities for children to access and explore multi-cultural resources.
- Staff understand how to promote children's imagination, for instance, through a range of construction, art and craft and role-play activities. They understand the importance of consulting children and involving them in decisions relating to their play.
- Leaders and managers seek the views of staff to plan appropriate professional development opportunities for them. For instance, through training staff to strengthen their knowledge and understanding of strategies to manage children's behaviour positively.
- Staff understand the importance of supporting children to adopt a healthy lifestyle, including regular opportunities to be physically active and to make healthy choices at mealtimes. Appropriate arrangements are in place to meet the needs of individual children with regards to their dietary needs.
- The arrangements for safeguarding are effective. Staff understand their responsibility to identify and refer concerns for children's welfare. They demonstrate a knowledge of broader safeguarding issues such as the 'Prevent' duty guidance. Appropriate arrangements are in place to ensure the ongoing suitability of the staff who work at the setting.
- Arrangements for risk assessments are secure to ensure the safety and suitability of the premises, equipment and resources.
- Leaders and managers recognise the importance of establishing strong partnerships with parents and other settings that children attend. Parents of older children state that children have lots of fun at the setting and they adore the staff. Older children present on the day of the inspection express the view that staff are nice to them.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Putney Wraparound registered in 2018. It is located in the London borough of Wandsworth. It operates from 7am to 8:55am and from 3:15pm to 6:30pm, Monday to Thursday, during term time. Six members of staff work directly with the children, of whom three are qualified at level 3 and three are qualified at level 2. The team is supported by a chef.

#### **Inspection activities**

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The manager accompanied the inspector on a tour of the premises and described how the provision is organised.
- The inspector spoke with parents and with older children who were present on the day of the inspection.
- The inspector had discussions with the manager and evaluated the arrangements for staff supervision, self-evaluation and plans for improvement.
- The inspector viewed a sample of documents including paediatric first-aid certificates and checks relating to staff suitability.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
