Summary of key findings

This provision meets requirements

- Staff know how to create a warm and friendly environment. They understand the importance of building positive relationships with children and giving them clear guidance about behaviour expectations. They know this will help children settle well and enjoy their time at the club.
- Staff understand the value of working closely with local schools to support children's emotional well-being and help children move confidently from school to the club at the end of the day.
- Staff demonstrate they can provide an interesting and stimulating environment indoors and outdoors for all children. They show they can provide activities that children will enjoy after school. They understand that by allowing children to make choices and access resources for themselves, they will be developing children's independence.
- Staff show an awareness of how to support children's good health. They are able to explain the importance of good hygiene practices, such as washing hands to prevent the spread of infection.
- Staff understand the importance of children having daily opportunities for outdoor play. They plan and provide a range of resources that allow children to be physically active.
- Leaders plan for children's safety through risk assessments and procedures in order to promote a safe and suitable environment.
- Staff demonstrate an awareness of safeguarding procedures. They are aware of their duty to report any concerns over children or adults to the relevant authorities. Staff know the signs to look out for which could indicate a child is at risk of harm.
- Leaders have recruitment procedures in place to ensure that employed staff are suitable to work with children. As part of this process, leaders plan for staff to take part in training and induction procedures.
- Staff are provided with regular meetings with leaders to monitor performance. Access to regular training is provided to all staff. For example, all staff have recently completed training on autism spectrum disorder to further extend their knowledge and understanding.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Fetcham Kids Club registered in 2020 and operates from the music hut on the grounds of Oakfield Junior School. The club employs four members of childcare staff. Of these, two hold appropriate early years qualifications at level 3 and above. The club opens from Monday to Friday, during school term time only. Sessions are from 3pm until 6pm.

Inspection activities

- This was the first routine inspection the club received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and staff and has taken that into account in their evaluation of the club.
- The inspector asked a range of questions throughout the inspection to establish the leadership team's understanding of the statutory requirements.
- The manager showed the inspector her policies and documents used when caring for children. The inspector looked at documents regarding evidence of the staff's suitability.
- The inspector took into account several parents' statements during the inspection.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
