Summary of key findings

This provision meets requirements

- Managers plan regular safeguarding training for all staff. Staff know how to report concerns about children's welfare. Staff have knowledge of a wide range of indicators that children may be at risk of harm.
- The provider ensures that managers recruit new staff safely. For example, managers complete suitability checks before staff members start working with children.
- Staff consider how to promote healthy lifestyles within the activities they plan. For example, they ensure that there are opportunities for children to be physically active and to learn about the benefits of nutritious food.
- Managers make sure that all staff hold a current first-aid qualification. Staff complete daily risk assessments of their environment and ensure that are closely supervised.
- Managers acknowledge the importance of supporting children's behaviour consistently. There are club rules, and staff set clear boundaries to guide children's behaviour.
- The provider demonstrates an understanding of the statutory requirements. All records and documentation required are completed by staff and reviewed by management.
- The provider, managers and staff have a good understanding of working in partnership with the school and parents. They have regular discussions to make sure all children's needs are met.
- The provider knows how to evaluate practice and seek the views of parents. Staff know they can feed back their suggestions to improve the service.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

It runs a breakfast club between 7.30am and 8.45am, and an after-school club between 3.15pm and 6pm. The club employs 3 members of staff. Of these, 2 hold qualifications at level 2 to teach physical education activities.

- The provider showed the inspector documentation to demonstrate the suitability of staff and the training they receive.
- The provider and the inspector discussed how partnerships with parents and school are supported.
