# Summary of key findings

#### This provision meets requirements

- The childminder demonstrates a good knowledge of how to plan and provide appropriate activities to support all aspects of children's learning. She is aware of the learning and development requirements. She explains clearly how she would use observations and assessments of children's learning to plan next steps for their development.
- The childminder demonstrates a robust knowledge of safeguarding, including what she should do if she has concerns that a child is at risk from harm. She is aware of the need to risk assess, to keep children safe and to minimise hazards. Since her registration, she has attended safeguarding training and paediatric first-aid training and has relevant documentation in place.
- The childminder knows how to make her home into a safe, secure and welcoming environment, where children have access to a wide range of resources and learning opportunities to meet their needs and extend their learning.
- The childminder understands the importance of self-evaluation to drive improvement in the quality of her provision. Since her registration, she has completed courses and training to extend her professional development.
- The childminder describes how she would use an appropriate range of resources and activities to promote and challenge children's learning, including building an awareness of healthy lifestyles. She plans to offer regular access to outdoor experiences and trips within the local community to help widen children's knowledge.
- The childminder intends to promote positive behaviour for children. She explains how she would support children's confidence and social skills. The childminder describes how she intends to encourage children to share resources and be kind to each other. She explains appropriate ways that she would use to encourage their self-care skills, taking into account their stage of development.
- The childminder has a good understanding of the importance of working in partnership with parents and other professionals. She plans to share information about children's care and their learning through discussion and written records to aid the continuity of approach.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2018 and lives in Rochdale. Sessions are from 8am to 6pm, Monday to Friday, all year round except for one week at Christmas and family holidays. The childminder will also operate on weekends from 9am to 6pm. The childminder provides overnight care. The childminder is able to provide funded early education for two-, three- and four-year-old children. The childminder holds an early years qualification at level 3.
