# Information about this children's home

In accordance with the home's statement of purpose, the home provides accommodation and specialist care for up to four male children with histories of trauma, disrupted attachments and harmful sexual behaviour. The organisation has its own separately registered school and therapeutic team. The school was not inspected as part of this inspection.

The manager has been registered with Ofsted since February 2022.

# This monitoring visit

This children's home was judged inadequate at the full inspection on 28 June 2022.

This monitoring visit took place to monitor the provider's and registered manager's response to the compliance notices served to them on 12 July 2022 in relation to Regulation 13 (1)(b) (2)(h) and Regulation 12 (1) (2)(a)(v)(vi). The responsible individual and the provider's quality manager were present throughout this monitoring visit, as well as the deputy manager. Ofsted was unable to review the registered manager's direct response to the two compliance notices served to her, as she was not present during the monitoring visit due to illness.

Due to matters that are being investigated by the provider, the notices were not received until 4 August 2022. Both sets of notices had been delivered and signed for at the home and the company registered address. The provider has taken steps to minimise the risk of mail being signed for and not immediately actioned in the future. The provider had not received the report following the full inspection of 28-29 July 2022 at the time of the monitoring visit. As a result, the progress against the requirements and recommendations made at this inspection have not been reviewed.



A review of staff, including the manager's understanding of their roles and responsibilities in terms of safeguarding has taken place. Where shortfalls have been identified, additional training has been provided. This has been further tested during staff supervision sessions. The provider has assured themselves that staff are clear about the expectations placed on them in terms of keeping children safe. An action plan is in place to continue to monitor the staff's response to safeguarding.

Written reviews have taken place regarding bullying and missing-from-care incidents. The outcomes of these reviews have been used to inform the action plan and individual personal improvement plans for all staff, including the registered manager.

A review has taken place of the monitoring systems. This has resulted in changes being made to practice. This includes the introduction of a weekly senior leadership meeting to review the week's events. This increase of managerial oversight is helping to ensure that regular reflection and oversight provide an additional layer of safeguarding.

Changes to the recording and reporting system have occurred. This is helping to alert senior leaders to all incidents. A change in protocol has been shared with all staff to prompt them on their responsibilities to alert senior leaders when incidents occur.

The provider has met the steps of the compliance notices that were specific to them.

full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1) (2)(a) (3)(d))	
In particular, ensure that employment checks are reviewed to ensure that all aspects of safer recruitment practice are being followed and all relevant checks are in place.	
The registered person must ensure that—	14 August 2022
within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person")—	
has spoken to the user about the measure; and	
has signed the record to confirm it is accurate; and	
within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the measure. (Regulation 35 (3)(b)(i)(ii)(c))	
This specifically relates to the registered provider ensuring that records include the date and time to ensure that the regulation has been met.
