What is it like to attend this early years setting?

The provision is inadequate

Weaknesses in the overall quality of the provision impact on children's safety and well-being. Staff do not take effective measures to ensure that children are safe at all times. Current procedures for risk assessments are not effective. Staff do not identify all potential hazards and eliminate them to maintain children's safety. Hazards, such as broken glass and broken equipment accessible to children in the outdoor area, were not identified during their morning checks. Children were able to access these areas, which put them at risk of harm. The provider does not make sure that essential qualifications, such as paediatric first-aid certificates, are kept up to date. This does not ensure children's safety in the event of an injury.

Staff working with children do not implement the curriculum effectively. The quality of teaching is poor. Some activities lack purpose because staff do not know what they want children to learn. Children have limited opportunities to explore and develop their imagination. They are told what they are doing by staff and have their hands guided as they paint. Children's learning is hindered by the lack of appropriate questioning for their stages of learning and understanding.

Despite these failings, children enter the playgroup happy and enjoy playing with their friends.

What does the early years setting do well and what does it need to do better?

- The provider was unable to provide any credible evidence that she had notified Ofsted of changes to the committee that has oversight of the playgroup. This a breach of statutory requirements.
- Monitoring of the quality of the playgroup is weak. The provider, who is also the manager, recognises that standards have dropped. However, she has failed to recognise the breaches in requirements of the Early Years Register and compulsory part of the Childcare Register. This is a significant cause for concern.
- While the provider ensures that newly appointed staff are suitable to work with children, she does not ensure that staff's ongoing suitability is monitored. This does not keep children safe from harm.
- Staff are unclear about the procedures to follow should they have concerns for children's welfare or in the event of an allegation against a member of staff. This puts children at risk.
- The provider has not ensured that in her absence the named deputy has the necessary skills and knowledge to deputise. This compromises children's safety and well-being.
- The current arrangements for monitoring staff's teaching and practice are not effective. Staff have limited opportunities to complete training to support their individual needs and professional development. This has a negative impact on



staff's teaching skills and the quality of education for children. Staff well-being is not supported well enough.

- At the time of the inspection not all records were available, including qualifications of staff, to demonstrate that qualification requirements are met.
- Children are encouraged to wash their hands before eating and after using the toilet. Staff prepare snacks and a hot lunch for children. However, staff preparing food have not had the appropriate food hygiene training. They display weak knowledge of food safety practice, particularly in relation to children's dietary and allergy requirements.
- The provider and staff do not support and teach children sufficiently well.

 Activities are overly ambitious for the children taking part, and they are not able to learn from them. For example, staff ask children to count and sound out letter names, when children have limited speech or skills in this area. This sets children up to fail and hinders their personal, social and emotional development.
- Overall, staff welcome children warmly at nursery. They are kind and develop positive relationships with children. Children hear polite words, such as please and thank you. Generally, children behave appropriately for their age.
- Parents are complimentary about the playgroup. They feel well informed about their child's progress and like the staff's warmth towards the children.

Safeguarding

The arrangements for safeguarding are not effective.

Children's safety cannot be guaranteed because the provider and staff are not vigilant enough. For example, the fire alarm and fire-fighting equipment are overdue for servicing, and there are trailing wires in the outdoor area that present a strangulation risk to children. The provider does not refresh their knowledge of safeguarding or demonstrate the ability to guide staff effectively on safeguarding matters. For example, she has not ensured that staff have up-to-date knowledge of the 'Prevent' duty guidance for England and Wales. She has not recognised that the safeguarding policy does not comply with local safeguarding partner's procedures.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:

Inspection activities

- This was the first routine inspection the setting received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the setting.
- The manager joined the inspector on a learning walk and talked to the inspector about their curriculum and what they want their children to learn.
- The inspector carried out a joint observation of an activity with the manager.
- The inspector held discussions with staff and parents and took their views into account.
- The inspector held discussions with the manager about nursery policies and procedures.
- The inspector viewed the provision and discussed the safety and suitability of the premises.
- The inspector observed activities and assessed the impact of these on children's learning and their progress.
- A range of relevant documents were viewed by the inspector, including suitability checks for adults working with children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
