#### Information about this children's home

The home is owned and operated by a provider owned by a national charity and is registered to provide care for up to five children with social and emotional difficulties.

There were no children living in the home at the time of this inspection.

There has been no registered manager since October 2021.

#### This monitoring visit

This monitoring visit was undertaken to determine the readiness of the home for the admission of children, and that the service is fully operational with sufficient staffing and management arrangements.

The home has been refurbished to a high standard and feels and looks like a family home for children. The provider has ensured that the home complies with relevant health and safety legislation and with relevant regulations about fire safety.

A new manager was appointed in March 2022 and has submitted her registration to Ofsted. Good progress has been made by the manager and the staff to meet the previous requirements made by Ofsted. These previous requirements were not a focus of this visit and have been repeated. However, the requirements around fire safety have been met.

There is sufficient staffing in place to ensure safe care to meet the needs of children for whom the home is registered to provide care.

The manager, since taking up her new role, has focused her attention on acting on and driving forward the home's action plan. The manager, supported by the deputy



manager, has ensured that the newly formed staff team has the required skills and knowledge to care for the children. This takes place through regular supervision, training, team meetings, learning circles, and a developing resource file.

The new staff have received a well-planned induction training programme and spend two weeks shadowing more experienced staff, at a sister home. This helps ensure that they understand the home's ethos as set out in the home's statement of purpose and are prepared for their role. Staff undertaking the induction programme reported that they felt it was informative and helpful to their role.

Safeguarding training is included in the induction training. Staff know what to look out for to identify child protection concerns and they understand what action to take to safeguard children.

The home has an up-to-date location risk assessment which identifies risks and opportunities presented by the home's location and identifies measures to reduce these risks. The assessment is informed by consultation with relevant local agencies.

The manager has been proactive in developing relationships with the home's neighbours. This has led to a considerable improvement in relationships.

Leaders and managers have sourced a new independent visitor for the home following the last full inspection.

Leaders and managers have demonstrated a proactive response to findings from the previous inspection visits. The home's action plan addresses all the findings. Managers continue to develop their ongoing professional development and embed new learning to continuously improve practice.

understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person;	
take effective action whenever there is a serious concern about a child's welfare;	
that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm;	
that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1) (2)(a)(i)(ii)(iii)(v)(vi)(b)(d))
