Summary of key findings

This provision meets requirements

- The childminder provides a safe and secure environment for children to play in. She makes good use of local parks and green spaces to give children plenty of opportunities to extend their physical skills outdoors.
- The childminder's home has defined areas to cover all areas of learning. The childminder uses games to support children to learn about turn taking, sharing and to improve their numeracy skills.
- The childminder explains how she uses her knowledge of child development to create a curriculum that is designed to ensure all children make good progress. She uses her observations of children to gain a clear understanding of each child's individual needs and what they need to learn next.
- The childminder talks about her approach to promoting positive behaviour. She gives children clear instructions. For example, on outings, when they stop to cross the road, children must dismount from their scooters to ensure they do not roll in to the road. The childminder uses various approaches to teach children about respect and friendship.
- The childminder provides children with healthy and nutritious meals. The childminder reminds children to drink water regularly on hot days to keep themselves hydrated and uses stories to help promote oral health. This helps children understand how to live healthy lifestyles.
- The childminder has two cats and a dog. The childminder explains that when children become comfortable around the animals, they can help to care for them. The childminder uses this opportunity for children to learn about animals and treat them gently.
- The childminder works closely with other settings children attend. She plays a key role in ensuring communication between parents and other settings remains effective. The childminder knows what children are learning at home and at other settings and she extends this learning in her setting.
- The childminder understands her responsibility to keep children safe. She understands the signs which indicate a child is at risk of harm. She knows the procedures to follow if she has any concerns about a child's welfare.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The childminder provided the inspector with a sample of key documentation on request.
- The inspector held discussions with the childminder about early childhood development, partnership working and safeguarding.
