Summary of key findings

This provision does not meet requirements

- The provider is not meeting some of the statutory requirements, including ensuring that staff hold the required childcare qualifications.
- The provider's systems for monitoring staff are not effective. Staff are not familiar with the club's policies and procedures. For example, staff are not aware of the club's complaints procedures. This means that they are unable to inform parents of the option to contact Ofsted, should they wish to, if they have concerns.
- Staff recognise the signs and symptoms that may indicate safeguarding and welfare concerns about children, should they arise. However, they lack the knowledge of how to follow appropriate safeguarding reporting procedures, should allegations be made against adults working with children. This compromises children's welfare and well-being.
- Staff demonstrate their understanding of planning a safe, interesting and well-resourced environment for children to access indoors and in the school playground.
- Staff discuss how they promote good hygiene habits with children, and encourage them to be independent and support their choices in activities.
- Staff understand how to manage children's behaviour appropriately and use praise and reward to support them to share, take turns and play cooperatively with each other.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

The club is open only to children who attend the school. The provider employs two members of staff. The club opens during term time from 3pm to 6pm, Monday to Friday.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The inspector spoke to staff and looked at relevant documentation, including the suitability of staff working at the premises.
- The manager gave the inspector a tour of the after-school club and explained what activities are on offer for children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
