## Summary of key findings

#### This provision meets requirements

- The provider has a clear understanding of how to safeguard children. She knows the possible signs and symptoms of abuse and neglect and how to refer any concerns to the relevant authorities.
- Daily checks and risk assessments are completed to identify and remove any potential hazards to children.
- The provider explains how she uses a range of teaching skills to meet children's individual learning styles and to support the curriculum. She has systems in place to observe and monitor children's progress and to swiftly identify any gaps in their learning.
- The provider has high expectations for children's behaviour. She explains how she will help children to develop positive relationships, and how she incorporates into daily activities the skills of sharing, turn taking and learning to respect others.
- The provider explains how she builds secure bonds with children to promote their emotional well-being and independence.
- The provider recognises the value of working closely with parents to promote children's progress.
- The provider keeps her knowledge up to date and refreshes her skills regularly through online training.
- The provider provides a personalised approach to learning, where staff consult children and follow their interests. Key persons use their ongoing assessments to identify children's next steps in learning. Each day, the key persons have a small group of children to focus on their learning.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
