Summary of key findings

This provision meets requirements

- The childminder has taken steps to update her safeguarding knowledge. She is alert to indicators that a child may be at risk of possible abuse or harm, and knows when to take action. The childminder has sufficient understanding of the procedures to follow if concerns arise about a child's welfare, or if an allegation is made against her or a household member. She has notified Ofsted of relevant members of her household, to allow the required suitability checks to be completed.
- The childminder describes the activities that she would provide for children of different ages and abilities, based on their interests. The childminder discusses how she would share information with parents about their children's achievements and development. She explains the action she would take if children do not progress in their learning as expected, with the involvement of parents.
- The childminder explains how she would use outings, such as visits to parks and local groups, to extend children's physical development. She shares how she would implement hygiene and personal care routines to promote children's health. The childminder describes her arrangements to manage risks in her home and while on outings.
- The childminder explains how she would help children to acquire positive social skills and to respect others. The childminder describes how she would help children to understand her expectations and behave well. She shares how she would help children to learn more about other cultures and communities.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
