Summary of key findings

This provision meets requirements

- The childminder's home is clean, organised and set up in an inviting manner. The garden is an extension to the indoor space, giving children the choice to move freely between both spaces. The childminder carries out daily risk assessments of the indoor and outdoor area to make sure the children are safe.
- The childminder shows, through discussion, good understanding of the areas of development and how to support children's learning in each area. She plans activities according to the children's interests and describes her practice as childled. She uses ongoing assessment to determine where children are and determine next steps.
- The childminder demonstrates a good understanding of how to effectively manage children's behaviour. She describes the importance of giving them emotional support and teaching them strategies to solve peer conflict. She respectfully explains why certain behaviours are unacceptable and what children can do instead.
- The childminder explains how important it is to establish a good relationship with parents and work together to support each child's development. She advises parents on strategies they can try at home and keeps them up to date with everything that happens at the setting.
- The childminder promotes healthy eating habits and helps parents become more aware of what they feed their child. She promotes oral hygiene, teaching the children how to brush their teeth after meals. She teaches children how to use tools, such as knives and forks safely, to promote independence and autonomy.
- The childminder attends regular training to keep up to date with child development research and safeguarding. She participates in weekly webinars and is committed to improving her practice and provision.
- The childminder demonstrates a good understanding of how to promote every child's learning and development. She has high expectations for all of her children and always seeks to challenge them through engaging learning experiences. She knows how to tailor each experience according to the child's needs.
- The childminder has clear safeguarding policies and procedures that are shared with parents upon registration. She has completed a full paediatric first-aid course and has a good understanding of how to proceed if she were concerned about a child's welfare. She has a good knowledge of the signs and symptoms of potential abuse.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The childminder showed the inspector the premises and explained the curriculum.
- The inspector checked the required documentation, including evidence of the suitability of those living in the household.
- The childminder explained her knowledge of how to safeguard children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
