Summary of key findings

This provision meets requirements

- The childminder has a clear understanding of how to observe children to understand what they know and what they need to learn next. She describes how she would use the early years foundation stage to provide children with a rich, diverse and challenging curriculum that ensures they are ready for the next stage of their learning.
- The childminder talks about how she will use the resources in her local environment, such as parks, green spaces and the local library to complement the learning which children do within the setting. She describes how she has a network of other childminders that she would meet with regularly. The childminder explains that this will help children to socialise and build friendships with others.
- The childminder understands the importance of promoting positive behaviour with children. She has house rules displayed and describes how she will role model behaviours, such as turn taking and sharing with children.
- The childminder recognises the importance of promoting healthy lifestyles with children and families. She talks about how she would provide guidance to parents on how to offer children a healthy balanced diet. The childminder displays posters within the setting to advise parents on the importance of good sleep patterns for children.
- The childminder understands the importance of working in partnership with parents. She describes how she will provide regular feedback to parents about their children's learning and development.
- The childminder understands the importance of teaching children about the world around them. She describes how she would promote British values, giving children choices and teaching them to respect the values and opinions of others.
- The childminder is reflective in her practice. She has a suggestion box set up ready for parents to leave feedback. The childminder has continued to invest in her own personal development by attending regular training courses that further her knowledge.
- The childminder has a clear understanding of how to safeguard children from harm. She describes how she would regularly risk assess her home environment to ensure that it remains safe for children. The childminder recognises the different forms of abuse which children may be at risk of. She clearly explains how she would record and report her concerns.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
