Overall outcome

The school does not meet the independent school standards relevant to the material change. The material change has already been implemented

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7 (a-b)

- The school has a safeguarding policy in place as required by the independent school standards (the standards).
- Leaders have not ensured that all necessary checks are made on alternative education providers before pupils attend, as required by the Department for Education (DfE) statutory guidance, 'Keeping children safe in education'.
- Staff do not have a good understanding of local safeguarding risks. They are also unclear about the school's whistleblowing procedures.
- Actions taken when there are concerns about pupils, including any follow up actions, and the impact of these actions, are not consistently recorded. There are gaps in safeguarding record-keeping.
- The actions taken by leaders when pupils need help and support is not consistently timely. This means that some pupils do not get the right support when they need it.
- Necessary checks have not been made on a contractor used by the school when there is potential for crossover between the contractors and pupils at the school.
- Leaders are unclear about the internet filtering system the school uses to prevent pupils from accessing inappropriate information. The school's designated safeguarding lead (DSL) did not know how leaders would be alerted to any unsafe internet use, or if there had been any alerts in the last year.
- Leaders are not consistently recording the name of a pupils' new school when they are removed from the school's roll. Sometimes leaders are unsure if a pupil has started at their new school.
- This standard is not met.

Paragraph 11

- The school has a comprehensive health and safety policy.
- Leaders carry out regular checks on the school building to ensure that it is safe. For instance, there is a legionella risk assessment. Frequent checks are made on the school's water supply. There is a comprehensive health and safety quality assurance calendar to ensure that all necessary checks are carried out in a timely manner.
- An additional building has been constructed on the school site to accommodate 20 more pupils. This building is well maintained and decorated. It is a pleasant space for both pupils and staff.
- This standard is met.

Paragraph 12

- Leaders have ensured that there is a member of staff trained as a fire officer. This member of staff carries out, and records, regular fire safety checks.
- A fire risk assessment has been completed and actions have been taken to remedy any issues found. For instance, a new fire alarm system has recently been installed. Fire exits are clearly shown. There is a fire assembly point. Regularly fire drills take place and are recorded. Emergency lighting is checked regularly by the fire officer.
- At the time of the inspection, no pupils required a personal emergency evacuation plan.
- This standard is met.

Paragraph 14

- Pupils are appropriately supervised. There are two members of staff in each class of no more than six pupils. Pupils are well supervised during breaktimes.
- This standard is met.

Paragraph 16 (a-b)

- Leaders have ensured that the school has a risk assessment policy in place.
- Examples of risk assessments seen during the inspection show that leaders take appropriate action to minimise risks to pupils. For instance, when they attend off-site provision for physical education (PE) lessons.
- This standard is met.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraph 18(1), 18(2)(a)-(e), 18(3), 18(4), 20(6)(a)-(c), 21(1), 21(2), 21(3)(a)-(b), 21(4), 21(6)

- At the start of the inspection, the single central record, which includes records of the checks made on staff, was not fully compliant with the DfE statutory guidance.
- Section 128 checks, which establish if individuals have been barred from taking part in the management of independent schools, had not been carried out on all necessary staff. Leaders ensured that this was resolved by the end of the inspection.

- The required checks on three members of the board of proprietors had not been recorded on the school's single central record. This was resolved by the end of the inspection.
- There was no information on the school's single central record to indicate that non-teaching staff's qualifications had been checked, where required. This was added to the school's single central record during the inspection.
- The school does not use supply staff. However, leaders are aware of the necessary checks they need to make should they use supply staff in the future.
- This standard is met.

Part 5. Premises of and accommodation at schools

Paragraph 22, 23(1), 23(1)(a), 23(1)(b), 23(1)(c), 23(2), 24(1)(a), 24(1)(b), 24(2)

- There are separate toilets for boys and girls. There is also a separate staff toilet. The additional new building contains two additional toilets for boys and two additional toilets for girls. There are no separate toilets for sixth-form pupils. However, leaders informed the inspector that younger pupils do not have access to the toilets at the same time as older pupils.
- There is a medical room with a sink, a folding bed and a first aid kit. The medical room is near to a toilet. There are no pupils with complex needs on the school's roll.
- Pupils have access to the changing rooms and showers at off-site leisure centres used by the school for PE lessons. The risk assessment specifies that pupils do not use the changing room and shower facilities at the same time as the public.
- These standards are met.

Paragraph 25, 26, 27, 27(a), 27(b), 28(1), 28(1)(a), 28(1)(b), 28(1)(c), 28(1)(d), 28(2), 28(2)(a), 28(2)(b)

- There are suitable lighting and acoustics in each classroom, including in the new additional building on the school's site.
- The school has external light, including outside the new building.
- The school has systems in place to check the buildings to ensure the health and safety of pupils. For instance, portable appliance testing is carried out and fire extinguishers are checked by an external company annually.
- The school is situated in the vicinity of a primary school and an ambulance centre. The new additional building on the school's site has been fenced off.
- Drinking water facilities are provided. During the inspection, drinking water signs were removed from the toilets.
- These standards are met.

Paragraph 29(1), 29(1)(a), 29(1)(b)

- Three off-site leisure centres are used for PE lessons.
- There is an outdoor grassed area for pupils to use at breaktimes.
- These standards are met.

Part 6. Provision of information

Paragraph 32(1)(c)

- The school's safeguarding policy is published on the school's website and is easily accessible to parents and carers.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1)(a)-(c)

- Leaders have not ensured that the standards are continually and consistently met over time.
- A group of pupils, who the inspector held a discussion with, say they feel safe in school. They told the inspector that when pupils make homophobic and transphobic comments that staff deal with this quickly. However, there is not a strong culture of safeguarding at the school. Some of the standards in Part 3 are not met. This puts pupils at risk.
- These standards are not met.

Schedule 10 of the Equality Act 2010

- Leaders have ensured that there is an accessibility plan. This plan covers the curriculum, improving information and improving the physical environment, as required by schedule 10 of the Equality Act 2010.

Compliance with regulatory requirements

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that are relevant to the material change, as set out in the annex of this report.

- Leaders have requested an increase in the number of pupils from 35 to 55. The additional building will accommodate an additional 20 pupils. However, not all the standards checked during this inspection are met.

Information about this school

- Parkside House School is an independent special school for pupils who have behavioural, emotional and social difficulties.
- All pupils have an education, health and care plan.
- There are 11 pupils who are currently attending the school part-time. These pupils will attend the school full-time from the end of September 2022.

- The school uses three unregistered alternative education providers: Wheels Project, Hill Top Farm and Northumbria Youth Action.
- The school uses three off-site leisure providers for PE lessons.
- The previous standard inspection took place in March 2020. The school was judged to be good in all areas.
- There has been a change of proprietor since the previous standard inspection. The new proprietors took over the school in September 2021.
- This is the school's first material change inspection.

Information about this inspection

- The inspection was commissioned by the DfE because the school applied to increase the number of pupils at the school from 35 to 55.
- The material change has already been implemented. The school is registered to have 35 pupils on roll. There are currently 46 pupils on the school's role.
- The DfE makes the decision about whether the material change should be approved.
- The inspector scrutinised the school's documentation relevant to the standards that the DfE requested were checked during the inspection.
- The inspector toured the school premises, including the additional building that has been built on the school site to accommodate an increase in pupil numbers.
- The inspector met with the headteacher, the deputy headteacher, who is also the DSL, a group of staff, and a group of pupils.
- The inspector met with the school's chair of the governing body, who is also the acting regional director. A virtual meeting was held with the chair of the board of proprietors.
- The inspector held a telephone discussion with the three alternative education providers used by the school. The inspector also held a telephone discussion with two of the three leisure centre providers used by the school for PE lessons.
