Summary of key findings

This provision meets requirements

- The childminder is kind, caring and welcoming. She is a knowledgeable practitioner and has a very good understanding of how children learn and develop. She clearly demonstrates how she will provide a broad and ambitious curriculum for all children, that considers their ages and stages of development, and prepares them well for the next stage of learning.
- The childminder understands her role and responsibilities in relation to keeping children safe. She knows the signs that indicate a child is at risk of harm and what to do if she has concerns. The childminder ensures her knowledge of safeguarding is up to date through training.
- The childminder has a very good knowledge of how to support children with their emotional literacy. She describes the importance of helping children to have emotional security, so that they have a solid base from which they can build all of their learning.
- The childminder talks about how she will support children who speak English as an additional language. She understands the importance of learning words and phrases in a child's home language. She would support children learning English by singing songs, reading books and using role play.
- The childminder describes how she will manage children's behaviour in a supportive way. For instance, she would help children learn about the impact of their actions on others, so that they can begin to learn to manage their own behaviour.
- The childminder understands that children need to develop a positive view of diversity and respect any differences between themselves and others. She intends to do this through conversations, celebrating the heritages of children at the setting and learning about festivals that people in the wider community celebrate.
- The childminder describes how she will build partnerships with parents by sharing information about children's progress and finding out about their interests and starting points. She will also give parents ideas about how to support children with their learning at home and ask parents for regular feedback about the service she offers.
- The childminder keeps her knowledge up to date through a variety of training courses. She recognises the importance of professional development to continuously improve the provision.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for the children in her care.
- The inspector had a learning walk of the areas of the premises used by children.
- The inspector discussed policies and procedures with the childminder and documentation that she will use when caring for children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
