Summary of key findings

This provision does not meet requirements

- The childminder does not have a secure knowledge of the Statutory framework for the early years foundation stage. She has a weak understanding of the learning and development requirements. She does not fully understand how to plan activities to help children make good progress in all areas of their development. The childminder does not understand the importance of assessing children's progress and planning their next steps effectively.
- The childminder is unfamiliar with the statutory requirement to provide parents with a written summary of their child's development in the prime areas between the ages of two and three.
- The childminder understands her responsibility to protect children and to keep them safe at all times. She completes regular safeguarding training to improve her knowledge, including safeguarding issues, such as female genital mutilation. The childminder understands how to refer any concerns about children's welfare to the relevant external agencies.
- The childminder understands the importance of carrying out risk assessments to minimise hazards. She maintains a current paediatric first-aid certificate to help her keep children safe.
- The childminder recognises the importance of encouraging children to follow healthy lifestyles and develop good hygiene routines. She explains how she promotes children's physical well-being. For example, she describes how she provides activities to help children exercise, such as trips to the local parks where children can climb and run around.
- In discussion, the childminder understands the importance of helping children to manage their behaviour and feelings. The childminder explains how she helps children to be kind and respectful to others.
- The childminder does not fully understand the importance of keeping her skills up to date. She has not ensured that she is familiar with changes to requirements or made use of professional development opportunities to help her support children's learning and their next stage of development.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the childminder.
- The childminder showed the inspector the premises and discussed how she ensures they are safe and suitable for children.
- The inspector discussed with the childminder how she intends to deliver the educational programme for children.
- The inspector sampled a range of relevant documentation, including training certificates.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
