## **Inspection judgements**

#### Overall experiences and progress of children and young people: good

At the time of this inspection, one child was living at the home. Since the last inspection, two children have successfully moved back to their families and two children moved to other children's homes run by the same organisation.

The manager undertakes comprehensive planning and assessment when offering a placement for each child. This is to make certain that staff have the appropriate skills and experience, while also considering the needs of other children. When more than one child was living at the home, the relationships between children were monitored effectively. When children experienced difficulties living together, the manager encouraged them to talk about their concerns to help improve their relationships.

Staff have helped the child to build positive relationships. Staff understand that positive attachments are a protective factor. Staff spend time with the child doing activities that she enjoys. Staff's use of encouragement and praise have helped the child to overcome her concerns about taking part in activities outside the home. With staff support, she enjoyed a trip to a theme park for the first time.

Through individual therapy sessions, the child has been supported to explore past experiences. Staff understand and practise the home's model of care. As a result, the child is starting to understand her past and her trauma. The child said, 'The staff have really helped me with my mental health. I feel happier nowadays.'

The child is helped to spend time with people who are important to her. Staff take her to see her family, who live some distance from the home. This ensures that she has positive experiences with her family and maintains relationships. The child knows that staff speak with her family. This has helped to provide a consistent approach in responses to the child.

The child attends the organisation's school, which is based in the grounds of the home. Her attendance levels are good and she is working towards mathematics and English qualifications. Staff support the child in class, which helps to provide consistency in care.

The environment is homely and comfortable. The child has decorated her bedroom with warm colours and lighting. She was proud to show the inspector her space. However, two bedroom doors do not close sufficiently to meet fire standards. This was raised at the last inspection and is restated.

#### How well children and young people are helped and protected: good

Staff provide a warm and nurturing environment for the child. The child said that she feels safe and likes living at the home. The manager reviews any risks in the



local community and shares this with staff. This helps staff keep the child safe when activities are planned outside the home.

The child's vulnerabilities are well understood by staff. Staff are guided to reduce risks to the child effectively. The child has made significant progress and has not been missing from the home since moving in. Staff review and update assessments and plans when risks change. The child has been involved in writing these plans. This helps staff manage risks with a consistent approach which the child has agreed to.

The child is supported and listened to when she has raised concerns. The manager takes immediate action and follows the organisation's policy to safeguard the child. Social workers, Ofsted and the local authority designated officer are informed and updated. The manager lets the child know what is happening. This ensures that the child feels listened to and believed.

Staff provide reassurance and a calm response when the child is upset. This helps her to manage her feelings and behaviour more effectively. Restraint is used as a last resort and only when necessary to safeguard the child and keep staff safe. Records are well written. The manager ensures that the child is spoken to after a physical hold. Staff are provided with support after an intervention. This helps them to reflect on the incident and consider alternative approaches in future. The manager has good oversight of all interventions.

Room searches take place only when a specific risk is identified. The child is asked for their consent. The searches have proved to be effective in reducing the risks of self-harm.

#### The effectiveness of leaders and managers: good

The registered manager is experienced and qualified. She is reflective and child-focused. She is aware of the team's strengths and weaknesses and has a development plan in place to achieve her vision. The manager has good support from the head of therapeutic care and head of quality assurance, who form part of the senior management team.

The manager has met one requirement and one recommendation from the last inspection. One requirement is restated.

Staff receive good-quality supervision which is reflective and focused on the needs of the child. Managers encourage staff to consider how they use the therapeutic approach, including the impact this has on the child. This enables staff to review the needs and progress of the child.

The staff are committed and form a long-standing team. This helps the child to develop trusting relationships with staff who are consistent in her life. The diversity in the team means that the child benefits from staff of different ages, gender and backgrounds. The child said, 'I like the staff. They are all different, just like me.'



The manager ensures that staff are trained to meet the complex needs of the child. All staff have completed the organisation's mandatory training. Staff are either qualified or working towards a relevant diploma within the agreed time frames. The home's therapist provides training for staff on the impact of trauma and behaviour. Staff are sufficiently skilled to provide tailored care and support.

The manager follows safer recruitment procedures. Staff move through a detailed induction and probation which is signed off by managers. The manager meets with new staff to talk about their development and how the work is affecting them. Staff said that they feel supported by the manager.

The manager has good oversight of the home. She monitors staff practice and the child's progress. Consultation with a child led to a change in the organisation's policy on keeping animals. Children who leave the home are encouraged to reflect, with the manager, on their experiences. The manager uses this feedback to change practice when possible. The use of external and internal monitoring helps the manager to make improvements.

Notifications are sent to Ofsted when incidents occur. However, in the manager's absence, leaders failed to send a safeguarding notification within agreed timescales. This oversight meant that Ofsted was unable to monitor the effectiveness of safeguarding measures taken to keep the child safe.

#### Recommendation

■ The registered person should have a system in place so that all serious events are notified, within 24 hours, to the appropriate people. The system should cover the action that should be followed if the event arises at the weekend or on a public holiday or in the manager's absence. ('Guide to the Children's Homes Regulations, including the quality standards', page 63, paragraph 14.13)
