Summary of key findings

This provision meets requirements

- The management team explain how they will support staff to promote children's independence. For example, they describe how they want staff to encourage very young children to wipe their own faces after eating. They explain how they intend for staff to support children with toileting, and to encourage older children to dress themselves and to serve their own meals.
- The management team understand how to support staff's practice. They will invite them to attend supervision, appraisal and staff meetings. The management team will observe staff and help them to reflect on and extend their teaching practice.
- The management team understand their roles and responsibilities to safeguard children. They understand the signs that may suggest a child is at risk of harm, abuse or radicalisation, and know where to report concerns about children's safety. The management team understand the importance of keeping staff's knowledge current so they can identify if a child's is at risk of abuse.
- The management team understand how to plan a curriculum to support children's learning. For example, they will help staff to observe and assess children's development and to identify what children will need to learn next.
- The management team intend to support staff to work in partnership with parents. Staff will invite parents to attend meetings to discuss their children's progress. Also, parents will receive regular written reports from staff to show their children's abilities.
- The management team explain how staff will support parents to continue their children's learning at home. For example, they intend to offer books for parents to take home to read to their children.
- The management team intend to support children to be prepared for the future. They will ask staff to find out about children's experiences at home when they first start. They intend for staff to provide children with opportunities to build on these experiences in the nursery.
- The management team plan to work in partnership with schools when children move on. For example, they intend to invite teachers to see the children in the nursery. Information about children's learning and development will be shared with school teachers.
- The management team understand the importance of following a robust recruitment procedure when they employ staff.
- The management team intend for staff to reinforce rules and boundaries in the nursery. These include to be kind, to take turns and to show respect for each other. They understand how to promote positive behaviour and to praise children's achievements.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed the safeguarding and welfare requirements with the management team.
