Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7-7(b)

- The previous standard inspection in 2021 found that safeguarding, including recruitment procedures, was weak. Staff were trained to understand how to safeguard adults, but not pupils. Leaders did not pay regard to government guidance.
- Safeguarding requirements are now met because leaders have reviewed and strengthened the school's approach to recruiting and training staff. The recruitment process reflects statutory guidance. Staff now receive suitable and timely training in both safeguarding and physical intervention.
- There is a more consistent approach to the de-escalation, positive handling and restraint of pupils. Leaders and staff now have a suitable working knowledge and understanding of the latest statutory guidance, as outlined in 'Keeping children safe in education' (September 2022).
- As a result, safeguarding arrangements are now effective in keeping pupils safe.

Paragraph 11

- At the time of the previous inspection, a suitable health and safety policy had not been written.
- This standard is now met because an appropriate policy has been written and is being implemented well.

Paragraph 15

- The admissions register was previously not compliant because it did not include all the required information.
- It is now compliant because it includes all the required information, including pupils' previous schools and their addresses.



Paragraph 16-16(b)

- At the time of the previous inspection, a suitable risk assessment policy had not been written.
- This standard is now met because the school's suitable policy is now supported by appropriate written risk assessments of both premises.
- The independent school standards (the standards) checked in this part are now met.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2), 18(2)(b), 18(2)(c), 18(2)(c)(iii) 18(3), 21(1), 21(3), 21(3)(a), 21(3)(a)(iii), 21(3)(a)(iii), 21(3)(a)(vi), 21(3)(a)(vi), 21(3)(a)(vii), 21(3)(a)(viii), 21(3)(b)

- The previous inspection found that the safer recruitment process did not reflect government guidance. The record of checks on staff suitability was not compliant. Some staff were working in the school without leaders making sure that all of the required checks had been correctly completed or recorded.
- The record of checks on staff suitability is now compliant. The inspection found that all the required checks are now undertaken and recorded accurately using a new online system.
- The standards checked in this part are now met.

Part 5. Premises of and accommodation at schools

Paragraphs 23(1), 23(1)(c), 24(1), 24(1)(a), 24(1)(b), 27, 27(b)

- The previous inspection identified a lack of outdoor lighting. There were also no medical room or shower and changing facilities at the 167 Old Kent Road premises.
- This inspection confirms that changing, shower and medical room facilities are now available at both sites. New outdoor lighting has also been installed.
- The standards checked in this part are now met.

Part 6. Provision of information

Paragraph 31(1), 31(1)(c)

- The school's safeguarding policy is available online.
- The standard checked in this part continues to be met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1)-34(1)(c)

- The previous inspection found that leadership, management and governance were weak. The proprietor was failing to meet their obligations. Some statutory requirements, including the independent school standards, were not met.
- This inspection found leaders to have taken decisive action since the previous inspection. As a result, the vast majority of the previously unmet standards are now met, including in relation to safeguarding and paragraph 34(1)(c).



- However, although leaders have been successful in focusing on improving some aspects of the school, especially safeguarding arrangements, they are not demonstrating the knowledge required to meet all the independent school standards consistently. Leaders are still not paying sufficient attention to detail. For example, amendments had to be made during the inspection to resolve inaccuracies in policies, and to ensure website compliance.
- The standards relating to leadership and management, in paragraph 34(1)(a) and 34(1)(b), remain unmet.

Schedule 10 of the Equality Act 2010

- At the time of the previous inspection, the school's accessibility plan was incomplete. It did not include planned actions to make the curriculum and information accessible.
- Leaders have reviewed and updated the school's accessibility plan. It now includes suitable actions to improve access in all the required areas, including the curriculum and written information.
- This requirement is now met.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- The Bridge Special Education Needs School is an independent special day school in the London Borough of Southwark.
- Pupils have a range of complex needs, including autism spectrum disorder. Many pupils are non-verbal. All pupils have education, health and care plans and are placed and funded by a range of local authorities.
- The school caters for pupils of compulsory school age at its main premises at 148–150 Old Kent Road, London SE1 5TY.



- Students aged 18 to 25 attend the premises opposite, at 167 Old Kent Road, London SE1 5TY.
- The proprietor has purchased new premises in the London Borough of Croydon. Once refurbishment works are completed, and the relevant material change permissions sought and obtained from the Department for Education, leaders' intention is to relocate all pupils to these premises in 2023.
- The school has a sole proprietor, who delegates governance to a governing body.
- The school's previous inspection in November 2021 was its first full inspection.
- Leaders do not make use of alternative provision.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This was the school's first progress monitoring inspection since its first full inspection in November 2021. The inspection was conducted without notice.
- Following the previous full inspection, leaders were asked to submit an action plan. This was evaluated by Ofsted as not acceptable in July 2022 and was subsequently rejected by the Department for Education.
- The focus of the inspection was to check whether the school complied with particular requirements within parts 3, 4, 5, 6 and 8 of the independent school standards.
- The inspection took account of a range of evidence to consider leaders' work to improve safeguarding, health and safety, and the premises.
- The inspector met with the headteacher regularly throughout the inspection. He also met with two teachers. On tours of both premises, he observed the school's pupils interacting with staff.
- There were no recent responses to consider on Ofsted's online survey for parents and carers, Ofsted Parent View.

Part 8. Quality of leadership in and management of schools

- 15 The standard in this paragraph is met if the proprietor ensures that an admission and attendance register is maintained in accordance with the Education (Pupil Registration) (England) Regulations 2006.
- 16 The standard in this paragraph is met if the proprietor ensures that—
 - 16(a) the welfare of pupils at the school is safeguarded and promoted by the drawing up and effective implementation of a written risk assessment policy; and
 - 16(b) appropriate action is taken to reduce risks that are identified.

 27(b) external lighting is provided in order to ensure that people can safely enter and leave the school premises.

 - 34(1)(c) actively promote the well-being of pupils.
