Summary of key findings

This provision meets requirements

- The childminder has a good knowledge and understanding of how she will support children in their learning. She confidently describes how she will plan activities that will build on children's current stages of development and interests. The childminder will assess children's progress and communicate with parents and other professionals if this is needed.
- The childminder explains how she will promote children's good health and hygiene practices. She demonstrates a good understanding of the need for children to be active outdoors. The childminder talks about how she will work with parents to ensure that healthy nutritious foods and snacks are provided to children.
- The childminder states that she will be a positive role model and will provide continuous guidance to children to help them learn about rules and boundaries. She explains that she will help children to learn to have positive values, be kind and have respect for others. This will help support children with their social skills in readiness for school.
- The childminder demonstrates a good understanding of working closely with parents and professionals. She describes how she will collect information about children that will help her to support their emotional needs, development and interests when they first start. Through regular discussions, she will offer further support to parents on how to extend children's learning at home.
- The childminder has a good knowledge and understanding of safeguarding children. She can confidently explain the signs and symptoms of abuse and the procedures to follow if she has any concerns. The childminder recognises the importance of risk assessing her environment to ensure that children are safe and secure at all times.
- Through discussion the childminder explains the importance of reflecting on the quality of service that she provides to families and children. She keeps abreast of any updates and attends training to further develop her knowledge and skills to support her practice.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
