

Compliance action taken for childcare provision

Summary of outcome

On 02 December 2022, we carried out an inspection and found the provider was not meeting some of these requirements.

The report and inspection outcome will be published in due course. Following the inspection, we served a welfare requirements notice on 07 December 2022. This is a legal notice that requires the provider to take the actions below within the timescales set out. The provider will be able to give parents further information about this.

Actions needed by 09 December 2022:

- implement the settings child protection policy and procedure in practice and take prompt action to share concerns about a child's welfare with the relevant agencies, where required
- implement the settings policy and procedure for administering medications to children, and ensure staff gather key information about the name, dose and reasons why the medicine is required and obtain written permission from parents
- ensure staff are deployed effectively and are aware of what children are doing during their play, so that they remain safe and their individual care and learning needs are consistently met
- ensure staff respond and manage children's behaviour appropriately so that they remain safe and their emotional need are met
- ensure staff keep an accurate and up to date record of children's dietary requirements and allergies
- ensure staff consistently implement robust and thorough hygiene and care practices to promote the good health of children
- ensure accurate and sufficiently detailed records are kept for each child in your care, and made available to those who require access to them.

On 12 December 2022, we carried out a regulatory visit. The focus of the visit was to check whether the provider had met the safeguarding and welfare actions actions, raised at their last inspection.



We found that the manager and staff have improved their knowledge and understanding of how to implement the setting's child protection policies and procedures in practice. The manager and staff are clear on how to follow the settings medication procedures, to help ensure the safe administering of medicines to children. The manager and provider have implemented new procedures to ensure staff complete accurate and sufficiently detailed information and records. Staff update children's individual health care plans when they are made aware of any changes, new allergies and/or dietary requirements. They have suitable procedures in place to help maintain children's health and hygiene. Staff understand how to use effective strategies to help manage children's behaviour.

We are satisfied the provider has met the safeguarding and welfare actions raised. The provider is still registered with Ofsted.

Publication of compliance action

We aim to ensure that the welfare of children and young people is protected in the services we regulate. The Childcare Act 2006 and accompanying regulations set out our responsibilities to regulate childminders and childcare providers. This includes the enforcement powers we have in relation to those registered providers who do not comply with the requirements for registration.

We publish details of any actions we take, or the childminder or childcare provider takes to bring about compliance with requirements on our website for a period of five years.
