Summary of key findings

This provision meets requirements

- Leaders ensure staff have the knowledge they need to keep children safe. Staff are confident to talk about the signs of potential abuse. They know how to raise any such concerns. This includes how to escalate concerns to outside professionals if the need arose to do so.
- Staff demonstrate they are able to plan and deliver a suitable programme of activities for children to enjoy after school or during the school holidays. They know how to plan activities that children will enjoy and that will build effectively on what children are learning elsewhere.
- Staff demonstrate they can provide a safe and secure environment for children. They know how to minimise risks and ensure that children are supervised closely at all times.
- Staff understand that in order to ensure children feel safe and secure they must be made to feel very welcome too. They understand the importance to younger children of having a key person who they will get to know especially well. Staff understand that this sense of security will help younger children confidently join in with all that is on offer at the club.
- Staff show a strong commitment to helping children enjoy leading an active lifestyle. They understand this will have a positive impact on children's good health, now and in the future. They explain how they will introduce children to a wide range of different sports and how they have trained staff to lead this part of the provision.
- Leaders at the club are committed to ensuring all children who attend are provided with a healthy snack or nutritious meal every day.
- Staff demonstrate how they teach children to keep themselves and others safe. Staff have simple 'club rules' to share with all children to help them take personal responsibility for their safety and behaviour. Staff explain how this also helps children understand the impact their actions could have on others. They talk about how this helps children learn right from wrong and to consider the needs of others.
- Leaders understand the value of working closely with staff at the schools children also attend. Leaders have established an effective two-way flow of information between staff at the club and staff at school. This means that the activities and routines can be adapted to best meet children's individual needs.
- Leaders know how to create a happy work environment where staff enjoy their work and feel valued and appreciated. Leaders have in place a well-established programme of training and career progression. This helps staff build further on their skills and knowledge. It also helps ensure children can attend a club where the atmosphere is happy and positive.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector found out about how the club is organised and how staff plan activities.
- A representative from the provider met with the inspector to explain how the club is run and staff are monitored and supported.
- The inspector looked at relevant documentation.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
