# Summary of key findings

#### This provision meets requirements

- The manager discusses how she regularly evaluates the provision. She describes how she will use feedback from staff, parents and the children to inform the improvements she makes. She talks about how she will review teaching practice, identifying any weaknesses and putting plans in place to support staff development.
- All staff undertake training to keep their knowledge and skills current. This includes safeguarding and first aid.
- The manager emphasises the importance of building strong links with the school. She describes how relevant information is shared on a daily basis between staff, ensuring the transition between school and after-school provision is seamless.
- The manager describes how children's physical development and healthy living will be supported. Children will have regular access to the outside space. Here they can run, jump, climb and join in with team sports activities. They will be provided with food that is healthy and nutritious.
- The manager explains how staff in the provision will support young children's personal, social and emotional development. They will be assigned a key person from the moment they start, who is responsible for their well-being and care needs. This will help children to settle quickly and feel emotionally secure.
- The manager describes the approach to managing children's behaviour. Staff will make sure children understand the routines, rules and the behaviour they expect. Good behaviour will be praised and celebrated. For example, children will put forward their friends and peers for a weekly 'act of kindness' award, which recognises behaviour over and above what is expected.
- The manager explains how staff are very experienced in supporting children with special educational needs and/or disabilities. They will work closely with parents, the school and other agencies involved in the children's care. This will help to provide targeted, consistent support and ensures children fully access the provision.
- Children's safety is paramount and taken very seriously by the manager. She describes how she carries out regular risk assessments of the play spaces, ensuring they are always safe for children to use.
- The manager shows how she ensures staff have a very good understanding of safeguarding. She ensures they know the processes they must follow if they are concerned that a child may be at risk from harm, including whistle-blowing. All staff have completed 'Prevent' duty, female genital mutilation and county lines training. The manager's designated safeguarding lead training is also up to date.
- The manager explains how she values working with parents and tries hard to keep them informed. She describes how staff will share policies with parents, so they understand how the provision is run and regular newsletters keep them abreast of any changes. Daily handover sessions will be an opportunity for staff to talk to parents about their children's care and to share the activities they have enjoyed.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
