Summary of key findings

This provision meets requirements

- Through discussion, the provider shows she is fully aware of her responsibility to safeguard children. She knows the signs which mean that a child may be at risk of harm. She explains the local procedure to report a concern about a child's welfare. The provider knows what to do if an allegation is made against an adult who works with children. She understands the importance of keeping her own and staff's knowledge up to date, through regular training.
- The provider has robust risk assessments in place. This ensures that the nursery is a safe and suitable place for children.
- The provider explains how she will monitor the quality of education that staff provide for children. She describes how she will provide targeted training if she observes any weaknesses in staff's teaching skills.
- The provider demonstrates an understanding of how young children learn and develop. She explains how she will organise stimulating activities based on children's interests and learning needs. She states how she will provide plenty of opportunities for children to explore through their senses, during activities such as cooking and baking.
- The provider demonstrates a sound understanding of how to support children's communication and language skills. She speaks about ensuring that children benefit from high-quality interactions. She explains how staff will introduce new words and engage children in story and rhyme time. She talks confidently about how to help children who speak English as an additional language, to become confident talkers.
- The provider describes how she will assess children's learning and what actions to take if she identifies any gaps. She will work closely with the local authority's inclusion team to ensure that children receive the support they need. This aims to help all children make expected progress from their starting points.
- The provider describes how she will support children's behaviour. She tells the inspector how she will promote children's understanding of the expectations by setting clear boundaries. She will teach children the language of feelings. For example, she will help children to recognise and name their emotions in different situations.
- The provider explains how she will support children to develop healthy lifestyles. She will help children to be active by ensuring that they participate in a wide range of physical activities, sports and games in the garden. The provider describes how she will ensure that staff help children to understand the importance of hygiene routines, such as washing hands and brushing teeth. The provider says she will work with parents to ensure that their children's packed lunches contain healthy food.
- The provider explains how she will plan to develop children's social skills and confidence. For example, she will encourage 'show and tell' sessions, in which children can share their experiences from home with their peers.
- The provider describes how she will build strong partnership with parents. She understands the importance of sharing information to support children's

learning. This shows that she is aware of how to support children to receive continuity of learning and care.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
