**Overall outcome** 

The school meets all of the independent school standards that were checked during this inspection

## Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b)

- The proprietor has ensured that leaders and staff have received appropriate safeguarding training. They know the procedures to follow should they have a welfare concern about a pupil or be worried about the behaviour of a member of staff. Leaders and staff know pupils and their families well.
- Leaders keep detailed safeguarding records. Leaders take, and then record, their appropriate actions after safeguarding concerns have been raised. Outside agencies are contacted promptly should the need arise.
- The safeguarding policy considers the latest statutory guidance. This includes updates around harmful sexual behaviours and ensuring that staff are recording any low-level concerns. Parents and carers can request a paper copy of the safeguarding policy as there is no school website.

Paragraph 16, 16(a), 16(b)

- The proprietor has ensured that there is an appropriate risk assessment policy in place. Pupils have their own bespoke risk management plans. These identify potential risks and have appropriate control measures in place to help to mitigate them. Staff must read and understand these plans before working with a pupil.
- Leaders ensure that risk assessments for any off-site visits are bespoke. They contain specific risk assessments for those pupils attending the visit. For example, extra staff are included on a visit should a pupil be at risk of potentially absconding.
- The school meets the independent school standards in this part.

- The proprietor has ensured that the single central record meets current requirements.
- Leaders have completed safer recruitment training. Therefore, all the required checks are undertaken on staff before they are allowed to start working at the school. The school does not currently use the services of supply staff.
- The school meets the independent school standards in this part.

### Part 8. Quality of leadership in and management of schools

- The proprietor has ensured that leaders demonstrate the knowledge and skills appropriate to their roles. This is helping to ensure that the independent school standards are consistently met. The standards checked as part of this inspection continue to be met.
- The proprietor undertakes frequent visits to the school. The recent appointment of an educational director has helped to ensure that safeguarding and safer recruitment practices are robust. Recent external audits have reassured the proprietor that leaders are consistently promoting pupils' well-being.
- The school meets the independent school standards in this part.

The school meets the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection. Not all of the standards and associated requirements were checked during this inspection.

#### Information about this school

- The school's previous standard inspection was from 16 to 18 November 2021. The school was judged to be good overall. During this inspection, the school successfully undertook a material change inspection to increase pupil numbers from four to 10.
- The headteacher at the time of the previous standard inspection left the role on 6 June 2022.
- A new headteacher was then appointed and left the role on 14 November 2022.
- The current headteacher has worked at the school since September 2020 and had previously been the care manager. She had been covering the headteacher role for a



month before permanently taking up the role on the day of this emergency inspection, 15 November 2022.

- The school is located at Church Road, Freiston, Boston PE22 ONX.
- The school provides full-time education for pupils with special educational needs and/or disabilities aged between seven and 18 years. All pupils have an education, health and care plan.
- Pupils have a range of learning difficulties including autism spectrum disorder.
- The school can admit boys and girls. However, at the time of this emergency inspection, only boys were on the school's roll.
- The school does not use the services of any alternative provisions.



## Information about this inspection

- The Department for Education commissioned Ofsted to undertake this emergency inspection due to concerns raised regarding the welfare, health and safety of pupils, the suitability and recruitment of staff and the quality of leadership and management.
- The inspection was carried out without notice.
- The inspector had various meetings with the headteacher. He also met individually with pupils and staff. He scrutinised various documents and policies, including those relating to risk assessment. He held a telephone conversation with the proprietor.
- To inspect safeguarding arrangements, the inspector checked the school's safeguarding policy and staff training and scrutinised safeguarding records. He scrutinised the single central record and the arrangements for recruiting staff.
