

# Childminder report

### What is it like to attend this early years setting?

#### The provision is inadequate

Children are cared for in an outbuilding in the garden. The childminder has not considered potential fire hazards, putting children at risk of significant harm. For example, the childminder uses a bottled-gas heater, surrounded by a fire guard. However, she does not risk assess it to ensure that it is used safely. Additional heating, directly where children play, is a significant burn risk to children. Following the inspection, the provider's registration was suspended as children may be at risk of harm should the provider have continued to operate.

Some children bring packed lunches, and others have a cooked meal. This is provided by the co-childminder, who cooks meals in the main house and brings them across to the outbuilding. Meals are served from the kitchenette in the outbuilding. However, the work surface in the kitchenette is cluttered and not suitable for serving meals. There is no running water in the building. Children wash their hands in a portable sink, with cold water that is stored in drink dispensers.

Children are exposed to risk of injury, as the environment is cluttered. Resources are stacked around the room, and children do not have space to move around freely or safely. Despite these significant weaknesses, children have access to a varied range of toys. They readily choose what they want to play with. The childminder engages with the children and joins in their games. For example, she joins a younger child in the role-play area and hides a doll under a blanket. They play peekaboo together.

# What does the early years setting do well and what does it need to do better?

- The childminder has not ensured that she is meeting fire regulations and does not risk assess the premises so that hazards are identified and reduced. As a result, the environment is not fit for purpose or safe for children to play.
- Children have very little natural light, as the windows on one side of the room are very small. In addition, the blinds are drawn on the window above the sectioned-off 'toilet area'. The childminder explained that this is to 'try and conserve heat'. Despite the use of heaters, the temperature of the room is not warm enough for children to be comfortable. The childminder told the inspector that they 'layer up' and wear coats when it is very cold.
- The childminder stacks equipment and resources on top of each other, posing a risk of injury to children if these were to topple. The childminder does not show the ability to identify and manage risks. At this inspection, a plug-in, oil-filled radiator was used as additional heating. This was placed where children play and was very hot, risking children being burned. The childminder had not considered this to be a hazard, although she did turn it off immediately when the risk was pointed out to her.



- Children do not have space to play freely. For example, when a child tries to push a soft toy around in a doll's buggy, there is no space to do so. The child becomes frustrated, removes the toy from the buggy and throws it across the room. Despite this, children do learn about what is acceptable behaviour. Overall, they play well together and develop friendships with their peers.
- The childminder does not ensure that she is meeting food hygiene regulations. She does not ensure that surfaces are wiped before use. The childminder pushes glue pots and other resources that have been used during the morning to one side on the work surface so that there is space to serve food.
- The childminder talks confidently about the children in her care. She knows where they are in their learning and what she needs to do to support their continuing progress. The childminder plans activities with her co-childminder to build on what children already know and can do. However, older children spend a lot of time playing alone, and the childminder does not ensure that activities offer them sufficient challenge. This does not help all children make the good progress that they are capable of.
- Children enjoy the childminder's interactions with them. The childminder builds close emotional bonds with them. She engages with children and chats with them as they play, providing a running commentary about what they are doing. During these times, she maintains children's interests and introduces vocabulary such as 'traffic lights' as they build a roadway together.
- The childminder demonstrates that she keeps parents informed about their children's day and learning.

# **Safeguarding**

The arrangements for safeguarding are not effective.

Children are exposed to numerous hazards in the premises, and the childminder does not have a good enough understanding of how to keep them safe. Despite this, she is aware of child protection. She has completed training in safeguarding and is aware of the indicators of abuse. The childminder knows how to report concerns and is aware of wider safeguarding issues. She understands her responsibility to recognise and support families and children who may be at risk of extreme behaviours or views.

# What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

The provision operates all year round, from 7.30am to 6pm, Monday to Friday, except for bank holidays and family holidays. The childminder holds an appropriate childcare qualification at level 6. She provides funded early education for two-, three- and four-year-old children.

#### **Inspection activities**

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- We carried out this inspection as a result of the risk assessment process, following information we received about this provider.
- The childminder talked to the inspector, to explain how the early years curriculum is organised.
- The inspector observed the quality of teaching during activities and assessed the impact this had on children's learning.
- The inspector spoke with the childminder at appropriate times throughout the inspection. She observed an activity and jointly evaluated this with the childminder.
- The inspector checked evidence of the suitability of all household members and qualifications of the childminder.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
