Summary of key findings

This provision does not meet requirements

- The childminder has not ensured that Ofsted is informed of all changes to her circumstances. For example, that she is now married. This is a breach of the requirements of the statutory framework.
- The childminder has kept all the relevant documentations updated. For example, her first-aid certificate. This demonstrates that she has the current knowledge and understanding of how to deal with accidents and injuries within her setting. She also has a valid public liability insurance in place.
- The childminder recognises the signs and symptoms that indicate a child might be at risk of abuse. This includes a clear knowledge of the 'Prevent' duty guidance. Hence, she understands when children are at risk of radicalisation or extreme views. She knows the procedures to follow and to ensure it is reported to the appropriate agencies to promote the safety of children.
- The childminder describes how she will keep the premises safe and secure for children. She explains that she will complete risk assessments each day to remove any hazards for children. The childminder understands the requirements to contact the local authority designated safeguarding officer and Ofsted if an allegation is made against her or a family member.
- The childminder thoroughly understands the learning and development requirements of the early years foundation stage. She clearly explains how she will provide a curriculum that covers all areas of learning and helps children to make the best possible progress.
- The childminder knows about the requirements to complete a written progress check when children are aged between two and three years. She understands the need to provide parents with a written summary of their child's development.
- The childminder explains how she will teach children to behave. She describes how she will encourage children to share and take turns. The childminder discusses how she will help children to be independent, such as dressing themselves, using the toilet and getting ready for school.
- The childminder describes how she will help children to understand about the differences between themselves and other children. She explains that she will use her wide selection of resources, books and activities that reflect the diverse world.
- The childminder discusses how she will share information with parents about the activities that their children have taken part in. She describes how she will share photos and use a secure online system, where parents will be able to see all the information she shares with them. Furthermore, she will also speak to parents each day. The childminder explains how she will collect the views of parents, to help to improve her setting.
- The childminder explains how she will ensure that children are provided with healthy and nutritious snacks and meals. She understands the need to cater for children's dietary requirements or allergies. The childminder knows the importance of supporting children's health and well-being. For example, she will



ensure children have daily fresh air and exercise. She will take children on visits in the local community, such as to parks, the woods, museums, playgroups, and the library.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- The inspector discussed with the childminder how she will keep children safe and protect them from harm.
- The childminder showed the inspector around the premises and discussed how she will ensure that they are safe and suitable.
- The childminder provided the inspector with a sample of key documentation on request.
