Summary of key findings

This provision does not meet requirements

- The childminder understands the importance of evaluating her service regularly to strive for improvements. However, she has a limited understanding of notifiable events that should be reported to Ofsted. The childminder has failed to inform Ofsted about changes within the required timeframe, including changes to her health and her address.
- The childminder knows how to identify and report concerns about children's welfare. She has a secure knowledge of the 'Prevent' duty guidance. The childminder understands the need to teach children about staying safe online.
- The childminder has a secure understanding of how to identify and minimise risks to children's safety and well-being, including through effective risk assessments.
- The childminder understands the importance of teaching children how to lead healthy lifestyles, including through regular access to physical exercise in the fresh air.
- The childminder knows how to manage children's behaviour positively. She plans to provide opportunities for children to learn about similarities and differences between the people in the local community and the wider world.
- The childminder knows how to plan a broad curriculum for children of different ages and abilities, including for children who speak English as an additional language. For example, the childminder knows how to support their understanding, listening and attention, as well as how to expand their vocabulary to build on their communication and language skills.
- The childminder knows how to share information about children's progress with parents effectively and how to support children's learning at home. This helps to provide consistency in children's learning and development.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

Inspection activities

- The inspector sampled documentation, including suitability checks and qualification certificates.
- The inspector discussed self-evaluation with the childminder.
- The inspector discussed with the childminder how she meets the requirements of the early years foundation stage.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
