## Summary of key findings

#### This provision meets requirements

- Through discussion, the provider demonstrates they have a good knowledge of the safeguarding policies and procedures. She is fully aware of her responsibility in keeping children safe. The provider describes the local procedures to follow in the event of any concerns about a child.
- The provider has risk assessments in place, and ensures the equipment and resources the children use are suitable and in good working order. They follow safer recruitment practices to ensure all staff are suitable to work with children.
- The provider has clear policies and procedures in place to ensure children are kept safe. Parents are requested to complete 'All About Me' booklets before their child starts at the club. These inform staff of emergency contact details, allergies, and any involvement from other agencies.
- The provider has a good knowledge of the learning and development requirements of the early years foundation stage. They discuss how they would organise the sessions and the activities they would provide for children.
- Planning would be done in-the-moment and reflect the age and interests of the children in attendance. On occasion, activities are planned and prepared in advance, for example when doing a baking activity, where the children have identified what they want to do.
- The provider understands the importance of the child's voice being heard and their opinion respected and considered. They have 'comment boxes' in the provision, where children are encouraged to share their feelings and opinions and make suggestions about future activities for the club. The provider has high expectations for behaviour and explains how she would consult the children about rules and guidelines for the provision.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
