

# Inspection of Noah's Ark Wrap Around Care

#### What is it like to attend this early years setting?

#### This provision meets requirements

Children show that they look forward to their time at the club. They arrive after school calmly and demonstrate that they are aware of the routine. For instance, they hang up their coats and bags before choosing from the wealth of exciting activities on offer. Children follow excellent hygiene practices. They wash their hands and sit down ready for their meal. They show high levels of independence as they use cutlery and choose their own spread, creating their own delicious and healthy wraps with a choice of fillings. Children show a preference for playing outside in the large outdoor area. They use their physical skills through a range of active games, such as carefully walking across wooden balance beams and playing ball games.

Children show kindness towards each other and learn to manage their own feelings and behaviour. They talk to staff about how they feel and use an emotion board to recognise how their feelings and behaviours may impact on others. Children offer hugs to one another and rush to cuddle staff when they arrive at the club. This demonstrates the positive relationships that children develop. Children benefit from designated rest areas, such as dens, and sensory resources, which help them to relax after their school day.

# What does the early years setting do well and what does it need to do better?

- The provider has an excellent overview of the quality of the provision. She is aware of its strengths and can identify any areas of improvement. The provider places a strong emphasis on staff development and well-being. She completes regular supervision sessions, and staff attend meetings. The provider offers training and coaching. This helps to keep staff's knowledge and skills up to date and to maintain a high-quality service for parents and children.
- Parents are complimentary about the staff and comment on how quickly their children settle into the club. Staff gather a wealth of information from parents to help them tailor the service to each child. Parents explain that the introductory sessions help them feel welcome and that children show they are eager to join in with everything on offer. They give examples of children showing parents an emotion board with pictures of smiling faces and telling their parents that this is how they feel when they are at the club. Parents are able to book their sessions through an online platform which offers them ease and flexibility.
- The provider offers an inclusive service. Children show that they feel valued and are treated with respect. They share their thoughts and ideas about what improvements they would like to see at the club. Children participate in tasks appropriate to their age. For instance, they help to set up the table ahead of mealtimes and help to tidy away toys and equipment.



- Children of mixed ages work collaboratively with one another during activities such as creating scented dough. They add cornflour, colouring and conditioner together to create their fluffy mixture. Children show confidence as they talk to visitors about what they are making. They show pride in their own achievements. For instance, they spend time drawing and creating pictures of their families and proudly show these to others.
- Children are encouraged to keep themselves safe. Staff complete regular risk assessments, including during school collection and drop off times. The provider has reviewed how mobile phones are used during these times and ensures that this is managed safely through her risk assessment procedures. Staff are clear about their roles and responsibilities. Children are encouraged to hold hands while walking and talk about road safety. They show good listening as they follow the rules of the club. Staff liaise with schools that children attend to help ensure that school collections and drop offs are managed effectively.

### **Safeguarding**

The arrangements for safeguarding are effective.

The provider and staff demonstrate an excellent understanding of safeguarding matters. There are detailed safeguarding policies and procedures in place, including the appropriate steps to take in the event of an allegation against staff. Staff complete regular and detailed training that helps keep their knowledge up to date. They create a safe space for children to relax and develop positive relationships with them. This helps children feel that they can talk about matters which might be affecting them. Staff understand the process to follow in the event of a concern about the welfare of a child. This includes any possible indicators of abuse.
